THROUGH 1894, WROTE THE FOLLOWING LETTER JUNE 24, 1893, TO "N.Y., N.H. & H.R.R. Co., LUCIAS TUTTLE, ESQ., V.P. & GENL MANAGER, DEAR SIR: IN REPLY TO MY RECENT LETTER TO PRESDT CLARK, WHICH HE REFERRED TO YOU, YOU WROTE TO ME THAT THE DAMMING BACK OF WATER ON THE EAST SIDE OF THE WEST RIVER MARSHES BY THE RAILROAD EMBANKMENT THAT CONNECTS THE N.H. & D. RAILROAD WITH THE N.Y., N.H. & H. RAILROAD SHOULD BE IMMEDIATELY DISCONTINUED. I CANNOT QUOTE YOUR LANGUAGE CORRECTLY BECAUSE I FORWARDED THE LETTER FROM YOU TO THE COMMITTEE OF CITIZENS REPRESENTING THE INHABITANTS OF THE SOUTH WESTERN PORTION OF THE CITY, BEFORE THE BOARD OF HEALTH. I FORWARDED YOUR LETTER, AS ABOVE STATED, ACCOMPANIED BY A LETTER OF MY OWN TO THEM IN WHICH I CALLED ATTENTION TO YOUR PROMPTNESS OF ACTION, SPRINGING FROM YOUR KIND-NESS OF HEART WHENEVER ROUSED BY THE INFORMATION OF ANY INJURY BEING DONE EVEN TO THE MOST HELPLESS, AND I VOUCHED FOR ALL YOU SAID AND PROMISED. THIS MORNING, TO MY GREAT MORTIFICATION, I RECEIVED A LETTER FROM THE BOSS OF THE COMMITTEE INFORMING ME, IN LANGUAGE PLAIN AND UNVARNISHED, THAT NOTHING WHATEVER HAD BEEN DONE, THAT THE STENCH IS INCREASING, AND THAT UNLESS RELIEF COMES PROMPTLY THERE WILL BE FEW SURVIVORS. I HAVE INVESTIGATED THE PREMISES THIS AFTERNOON AND FIND THAT NOTHING REMEDIAL HAS BEEN DONE. THE TIDE WAS OUT AND A CONSIDERABLE PORTION OF THE INCLUDED FLATS WERE COVERED BY WATER, AND THE REMAINDER COVERED BY DECAYED AND DECAYING SALTGRASS, WHICH EMITTED A COPIOUS AND VERY DISAGREEABLE AFFLUVIUM. I DIDNOT TASTE THE DAMMED WATER TO LEARN WHETHER IT WAS SALT OR FRESH BUT I THINK IT WAS FRESH WATER FROM THE SPRINGS AT THE EDGE OF THE MEADOWS WHICH WILL KILL THE SALTGRASS AS IT GROWS ABOVE THE GROUND UNLESS LARGELY MIXED WITH SALT WATER, IN THIS CASE DAMMED BACK. I THINK THAT THERE SHOULD HAVE BEEN TWO CULVERTS AT THE SOUTH OF WASHINGTON STREET AND THREE AT THE NORTH. PLACED AT THE OLD DITCHES THAT YOUR EMBANKMENT HAS FILLED. I HOPE YOU WILL HAVE DONE PROMPTLY WHAT-EVER IS NECESSARY. I AM REJOICED AT YOUR SUCCESSFUL EFFORTS IN REDUCING TIME BETWEEN NEW YORK AND BOSTON, IN THE FOUR TRACKING OF YOUR ROAD BETWEEN NEW YORK AND NEW HAVEN AND IN SATISFYING THE BOSTON FRUIT DEALERS AND EATERS IN THE MATTER OF TERMINAL ACCOMMODATIONS, BUT PLEASE KEEP IN MIND THAT THE LAW REQUIRES THE BOARD OF HEALTH OF NEW HAVEN TO PROMPTLY TAKE ANY MEASURES DEEMED NECESSARY TO PRE-SERVE THE PUBLIC HEALTH. AND IT IS NOT NECESSARY TO REMIND YOU OF THE CONSTANT FEELING OF ALARM EXISTING THIS SUMMER, AND THE WATCHFULNESS OF THE PEOPLE OVER THE BOARD OF HEALTH, TO SEE TO IT THAT IT DOES ITS DUTY. CHOLERA, TYPHUS AND TYPHOID FEVERS DYPHTHERIA AND SCARLET FEVER WILL NOT WAIT ON HESITATING ENGINEERING AND SLOW CONSTRUCTION. YOURS TRULY, J.B. SARGENT, MAYOR, & EX.OF. PRESDT BOARD OF HEALTH" . 

THE AGREEMENT IS IN THE HANDWRITING OF JOSEPH BRADFORD SARGENT (1822-1907), PRESIDENT OF THE CORPORATION AND A NEW YORK PART-NER. IT IS NEITHER DATED NOR SIGNED, BUT OBVIOUSLY DATES FROM LATE 1866 OR EARLY 1867. YE EDITOR COULD NOT LOCATE A SIGNED DOCUMENT, AND THERE MAY HAVE BEEN NONE, FOR THE MEMBERS OF THE PARTNERSHIP WERE THE CONTROLLING STOCKHOLDERS OF THE CORPORATION. "IT IS HEREBY AGREED BY AND BETWEEN SARGENT AND COMPANY A JOINT STOCK COMPANY ORGANISED UNDER THE LAWS OF THE STATE OF CONNECTICUT RELATING TO JOINT STOCK CORPORATIONS, AND LOCATED IN NEW HAVEN IN SAID STATE OF THE FIRST PART AND SARGENT & COMPANY OF NEW YORK A PRIVATE COPARTNERSHIP LOCATED AND DOING BUSINESS AS HARDWARE MEERCHANTS AT NO. 70 BEEKMAN STREET NEW YORK, OF THE SECOND PART AS FOLLOWS THE PARTY OF THE FIRST PART AGREES TO SELL TO THE PARTY OF THE SECOND PART ALL THE GOODS MANUFACTURED BY SAID PARTY OF THE FIRST PART UP TO THE WANTS AND ORDERS OF SAID PARTY OF THE SECOND PART, AND TO THE EXCLUSION, IF NECESSARY, OF SALES TO OTHER PARTIES. THE PARTY OF THE SECOND PART AGREES TO TAKE FROM THE PARTY OF THE FIRST PART ALL THE GOODS MANUFACTURED BY THE PARTY OF THE FIRST PART UP TO THEIR ABILITY TO SELL, AND AGREES NOT TO BUY GOODS SIMILAR TO THOSE MANUFACTURED BY THE PARTY OF THE FIRST PART FROM ANY OTHER PARTY - NO GOODS, THE SALE OF WHICH BY THE PARTY OF THE SECOND PART, WOULD DECREASE OR LESSEN THE SALES OF THE GOODS MADE BY THE PARTY OF THE FIRST PART. THE PARTY OF THE SECOND PART AGREES TO ACCEPT THE TIME DRAFTS OF THE PARTY OF THE FIRST PART, OVER AND ABOVE THE INDEBTEDNESS FOR GOODS OF THE PARTY OF THE SECOND PART TO THE PARTY OF THE FIRST PART, TO ANY REASONABLE AND SAFE AMOUNT DESIRED BY THE PARTY OF THE FIRST PART WITH-OUT SECURITY AND FREE OF CHARGE - THE PARTY OF THE SECOND PART AGREES TO MAKE ALL PURCHASES OF MATERIAL AND SUPPLIES AND DO ALL THE SHIPPING &C FOR THE PARTY OF THE FIRST PART WITHOUT ANY CHARGE EXCEPT CARTAGES &C ACTUALLY PAID OUT. ALSO TO ADVANCE OR LEND MONEY TO THE PARTY OF THE FIRST PART IN SUCH AMOUNTS AS MAY BE CONVENIENT AND SAFE WITHOUT OTHER CHARGE THAN INTEREST AND IT IS FURTHER AGREED THAT THE PRICES OF THE MERCHANDISE SOLD BY THE PARTY OF THE FIRST PART TO THE PARTY OF THE SECOND PART SHALL BE TEN PER CENT UNDER REGULAR PRICES TO THE JOBBING TRADE, AND PRICES GUARANTEED - AND IT IS FURTHER AGREED THAT THE PARTY OF THE SECOND PART SHALL KEEP TRUE AND ACCURATE ACCOUNTS OF THEIR BUSINESS AS MERCHANTS IN NEW YORK, AND THAT SAID ACCOUNTS SHALL BE SUBJECT TO INSPECTION OF THE DIRECTORS OF THE SAID PARTY OF THE FIRST PART AND THE SAID PARTY OF THE FIRST PART SHALL HAVE THE RIGHT TO TAKE THE BUSINESS OF THE SAID PARTY OF THE SECOND PART (AS MERCHANTS IN NEW YORK) WITH ALL PROFITS FROM JULY 1, 1866 AT THE NEXT ANNUAL MEETING (IN 1867) OR AT ANY CALLED MEETING (CALLED FOR THE PURPOSE) OF THE STOCKHOLDERS OF THE SAID PARTY OF THE FIRST PART BY PAYING THE SAID PARTY OF THE SECOND PART THE SUM OF FIVE THOUSAND DOLLARS. THE VOTE TO BE TAKEN IN THE USUAL MANNER - AS THE VOTE WAS TAKEN ON DECIDIN TO TAKE THE BUSINESS OF THE PARTY OF THE SECOND PART AT THE ANNUAL MEETING OF JULY 1866 BY A MAJORITY OF STOCKHOLDERS PRESENT."

JOHN MAKERNES (ABOUT 1460-AFTER OCT. 14, 1515), ANCESTOR OF MOST OF US, LIVED IN THYNDEN (ALSO CALLED THINGDON AND LATER FINEDON) IN THE COUNTY OF NORTHAMPTON, ENGLAND, ABOUT THIRTEEN MILES NORTHEAST FROM THE TOWN OF NORTHAMPTON. HIS WIFE, ELIZABETH, WHOM HE MARRIED ABOUT 1490 SURVIVED HIM, DYING AFTER APRIL 24, 1533. THEY HAD SIX CHILDREN, THOMAS, WHOSE WIFE'S NAME WAS ELYN OR ELLEN, BEING OUR FOREBEAR. JOHN'S GREAT GRANDDAUGHTER, ELLEN MAKERNES, WAS THE WIFE OF ROGER SARGENT (ABOUT 1562-1649). (SEE GENEALOGICAL CHART IN SARGENTRIVIA OF APRIL 25, 1949). JOHN MAKERNES' WILL WAS DATED OCTOBER 14, 1515. IT IS PRINTED IN N.E. HISTORICAL AND GENEALOGICAL REGISTER IN 1917 (VOL. 71) FROM NORTHAMPTON WILLS, BOOK A, P. 279 (FOR YEARS 1510 TO 1520). THE WILL PROVIDES AS FOLLOWS: "TO BE BURIED IN THE CHURCH OF OUR LADY OF THYNDEN. TO THE MOTHER CHURCH OF LINCOLN 120. TO THE HIGH ALTAR OF OUR LADY OF THYNDEN 20D. WITNESSES: WILLM STOKS, VICAR OF THYNDEN, SYR RICHARD KNYGHTON, CAPN EDMUND WALYS, RICH WALTR, RIC GRENE (?) WITH MORE OF THE SAME TOWN. (NO RECORD OF PROBATE.) OGRELL (MENTIONED IN THE WILL, USUALLY SPELT "HOGGEREL" OR "HOGREL") WAS A YOUNG SHEEP. A 17TH CENTURY DEFINITION: "THE FIRST YEAR WE CALL IT IN ENGLISH A LAMB, SO THE SECOND YEAR A HOG, LAM-HOG, OR TEG IF IT BE A FEMALE, THE THIRD YEAR HOGGRILS AND THEIVES."

THE SARGENT COAT-OF-ARMS WAS SHOWN IN SARGENTIRIVA OF MARCH 25TH, REPRODUCED FROM THE 1895 EDITION OF THE SARGENT GENEALOGY. JOHN SMITH SARGENT, COMPILER OF THE ENGLISH ANCESTRY SECTION, EM-PLOYED RESEARCHERS IN ENGLAND AS EARLY AS 1887. THE FOUR SARGENT COAT-OF-ARMS (THE NAME IS VARIOUSLY SPELLED) ILLUSTRATED BELOW ARE REPRODUCED FROM AN EARLY MANUSCRIFT REPORT OF ONE OF THE RESEARCHERS. AND WERE APPARENTLY DRAWN BY HIM, THE LOWER TWO IN COLORS. THE ONE AT THE UPPER LEFT IS THAT OF THE SHROPSHIRE SARGENTS, OF WHOM THE EARLIEST KNOWN WAS ADAM LE SERJANT IN 1324. IT WILL BE NOTED THAT EXCEPT FOR THE CREST IT IS THE SAME AS THE ONE WE CLAIM. IT IS DESCRIBED: "ARGENT A CHEVRON BETWEEN THREE DOLPHINS EMBOWED NAIANT SABLE." THE CREST: "TWO EAGLES WINGS CONJOINED AND INVERTED PROPER." THE ARMS AT THE UPPER RIGHT IS THAT OF THE STAFFORDSHIRE SARGENTS, OF WHOM THE EARLIEST REPORTED WAS LAWRENCE SERJEANT, LIVING IN 1605. THIS IS ALSO THE SAME ARMS, BUT A DIFFERENT CREST, DESCRIBED AS "A DOLPHIN EMBOWED SABLE BETWEEN 2 WINGS ARGENT." THE ARMS AT THE LEFT IN THE BOTTOM ROW CONTAIN A "BEND" INSTEAD OF A "CHEVRON" AND BOTH THE SHIELD AND THE CREST ARE IN "AZURE". IT IS USED BY THE SARGENTS OF KENT, OF WHOM LIEUTENANT GENERAL JOHN NEPTUNE SARGENT (LIVING IN 1887) WAS A DISTINGUISHED MEMBER. THE RIGHT LOWER ONE IS USED BY THE NORTHUMBERLAND SARGENTS AND DESCRIBED AS "GULES ON A BEND NEBULÉE OR BETWEEN TWO DOLPHINS ARGENT." THE CREST IS SIMILAR TO OURS. THERE ARE COATS-OF-ARMS OF OTHER SARGENTS, BUT THE DOLPHIN APPEARS IN ALL THAT YE EDITOR HAS SEEN. THE DOLPHIN IS FOUND EARLY IN HERALDRY IN FRANCE. IT WAS USED BY THE DAUPHINS IN FRANCE AND OCCURS IN THE ARMS OF MANY OTHER BRITISH FAMILIES. THE MANUSCRIPT REPORT FROM WHICH THESE ILLUSTRATIONS ARE TAKEN IS OF 12 PAGES, THE LAST HALF BEING DEVOTED TO THE COLYER (OR COLLIER) FAMILY, ONE OF WHOSE MEMBERS, AGNES, BORN PROBABLY BEFORE 1600, MARRIED THOMAS SARGENT OF STAFFORDSHIRE. IN REPRODUCING THESE COAT-OF-ARMS YE EDITOR HAS HAD THE DRAW-INGS PHOTOGRAPHED, AND HAS NOT FOLLOWED THE CUSTOMARY PROCEDURE OF INDICATING GULES (RED) BY VERTICAL LINES OF SHADING, AZURE (BLUE) BY HORIZONTAL SHADING, SABLE (BLACK) BY CROSSED VERTICAL AND HORIZONTAL LINES OF SHADING, OR (GOLD) BY SMALL DOTS, ETC.
