AT THE LUNCHEON ALSO WERE JANET'S SISTER, MRS. TRACY FABIAN, AND HER FAMILY, AND HER BROTHER CHARLES AND HIS FAMILY. JANET ATTENDED THE DAY SCHOOL IN NEW HAVEN, DREW SEMINARY, CARMEL, N.Y., AND GRADUATED FROM SKIDMORE COLLEGE IN 1946. SHE IS A GRANDDAUGHTER OF THE LATE MR. AND MRS. FREDERICK SCHNEIDER OF PELHAM MANOR, N.Y., AND OF THE LATE MR. AND MRS. JOHN HUTTON OF NEW YORK. SHE IS EMPLOYED IN NEW YORK BY VERA MAXWELL, INC., AND SHARES AN APARTMENT WITH OTHER GIRLS AT 325 EAST 41ST STREET. JOHN PREPARED FOR COLLEGE AT TAFT SCHOOL, ENTERED YALE WITH THE CLASS OF 1945W. HIS COLLEGE COURSE WAS BROKEN BY SERVICE WITH THE ARMY IN GERMANY AND IN THE PHILIPPINES, AND HE GRADUATED IN 1949. HE HAS SINCE BEEN WITH THE NEW YORK TRUST COMPANY. THEY PLAN TO BE MARRIED IN TRINITY CHURCH, NEW HAVEN, LATE IN JUNE.

EMILY SARGENT LEWIS, DAUGHTER OF WILFRED SARGENT LEWIS, AND DAVID LATTIMORE, SON OF OWEN LATTIMORE, WERE MARRIED AT NOON SATURDAY, FEBRUARY 24TH, IN ST. JOHN'S EPISCOPAL CHURCH IN NEW HAVEN. THE REVEREND ROBERT C. DENTAN, PH.D., PROFESSOR AT THE BERKELEY DIVINITY SCHOOL, PERFORMED THE CEREMONY IN THE ABSENCE OF THE RECTOR, THE REVEREND JOHN WHITE GUMMERE, S.T.B. THE REVEREND FREDERICK R. GRIFFIN D.D., MINISTER EMERITUS OF THE FIRST UNITARIAN CHURCH IN PHILADELPHIA TOOK THE BETROTHAL AND SPOKE TO THE BRIDAL PAIR AFTER EACH HAD PLIGHTED TROTH TO THE OTHER. MR. GRIFFIN MARRIED THE BRIDE'S FATHER AND MOTHER IN BEDFORD VILLAGE, NEW YORK IN 1930; AND HE ALSO MARRIED THE BRIDE'S AUNT MILLICENT AND THE BRIDE'S COUSIN, EMILY PETTIT WHITNEY. BOTH MINISTERS WORE THE HOODS OF THEIR DEGREES, MR. DENTAN'S, BLUE FOR HIS YALE DOCTORATE IN PHILOSOPHY; MR. GRIFFIN'S SCARLET FOR HIS HARVARD DOCTORATE IN DIVINITY. BEFORE THE CEREMONY THE ORGANIST PLAYED CESAR FRANCK'S PANIS ANGELICUS AND AFTERWARDS PURCELL'S TRUMPET VOLUNTARY. EMILY'S FATHER GAVE HER IN MARRIAGE. HER SISTER ABIGAIL WAS HER MAID OF HONOR AND HER SISTER FAITH WAS FLOWER GIRL. MR. LATTIMORE WAS DAVID'S BEST MAN. NORMAN PETTIT, EMILY'S PHILADELPHIA COUSIN, AND DAVID'S OLD SCHOOL FRIEND RODNEY DENNIS WERE THE USHERS. EMILY WORE A CREAM COLORED SATIN GOWN TRIMMED WITH SEED PEARLS FROM THE WEDDING DRESS OF HER GRANDMOTHER EMILY SARGENT LEWIS; AND SHE WORE A LACE CAP AND CARRIED A LACE HANDKERCHIEF WHICH WERE WORN BY HER GREAT GRANDMOTHER, SARAH SHAW SARGENT, AT HER WEDDING IN NANTUCKET IN 1856. HER BOUQUET WAS GARDENIAS, STEPHANOTIS AND IVY. ABBY'S MAID OF HONOR GOWN WAS TERRA COTTA TAFFETA WITH A CAPELET AND A VELVETEEN HAT TRIMMED WITH SEED PEARLS, AND HER BOUQUET WAS TALISMAN ROSES, CARNATIONS AND IRIS. LITTLE FAITH, SEVEN YEAR'S OLD, WAS DRESSED SOMEWHAT TO MATCH HER BIG SISTER, THE BRIDE, IN A CREAM COLORED SATIN GOWN WITH A LACE CAPELET AND A CHAPLET OF SPRING FLOWERS; AND SHE CARRIED VIOLETS AND DAISIES. AFTER CHURCH THE WEDDING PARTY WENT AROUND THE CORNER TO THE LEWIS' HOUSE AT 188 BISHOP STREET (NEXT TO THE PUBLICATION OFFICE) AND HAD BREAKFAST WITH CHAMPAGNE AND WEDDING CAKE. EMILY'S MOTHER WORE A COPPER COLORED SATIN GOWN WITH CREAM COLORED HAT; AND DAVID'S MOTHER WORE A FOREST GREEN DRESS. BOTH LADIES LOOKED VERY HANDSOME, AND BOTH WORE ORCHIDS AT THE SHOULDER.

AFTER THE TOASTS HAD BEEN DRUNK AND THE CAKE CUT AND DISTRIBUTED IT WAS TIME FOR THE BRIDE AND GROOM TO GO. EMILY THREW HER BOUQUET FROM THE STAIR LANDING (AND ABBY CAUGHT IT) AND DASHED OFF IN A NAVY BLUE GABARDINE SUIT AND HAT ON HER WAY WITH DAVID FOR A FEW DAYS IN NEW YORK. AFTER THIS BRIEF HONEYMOON EACH RETURNED TO COLLEGE, EMILY TO BARNARD AND DAVID TO HARVARD. THEY WILL HAVE A SECOND HONEYMOON AT THE TIME OF THE SPRING VACATIONS. IF DAVID'S MILITARY SERVICE IS DEFERRED UNTIL HIS GRADUATION IN JUNE 1952, THEY WILL BOTH GO TO SUMMER SCHOOL AT JOHN HOPKINS THIS JUNE, AND LIVE AT RUXTON WITH THE SENIOR LATTIMORES; AND IN THE FALL THEY WILL LIVE IN CAMBRIDGE WHILE DAVID IS A SENIOR AT HARVARD.

JAMES C. SARGENT, SON OF MURRAY SARGENT, AND BECKY, HIS WIFE, HAVE PURCHASED AN OLD HOUSE IN NORTH STAMFORD, CONN., IN THE HIGH SECTION OF THE "RIDGES". JIM SAYS THE HOUSE DATES BACK TO COLONIAL DAYS BUT "IS COVERED WITH MUCH BASTARD ARCHITECTURE—A DORMER HERE, AN ADDITION THERE—WHICH HAS ALL BUT OBLITERATED THE OLD COLONIAL LINES". SARGENT & CO. 1866 CATALOGUE ON THE TITLE PAGE STATES: "PRICES OF HARDWARE SOLD BY SARGENT & CO., NO. 70 BECKMAN STREET AND NO. 68 GOLD STREET, NEW YORK, RECEIVED FROM MANUFACTURERS FOR WHOM THEY ARE NEW YORK AGENTS, FROM FACTORIES THE ENTIRE PRODUCTIONS OF WHICH THEY TAKE BY CONTRACT, AND FROM THEIR OWN FACTORIES IN NEW HAMPSHIRE, VERMONT, MASSACHUSETTS, CONNECTICUT AND NEW YORK. \*\*\*" OF "THEIR OWN FACTORIES" THE MASSACHUSETTS FACTORY IS THE SARGENT CARD CLOTHING CO. AT WORCESTER AND THE CONNECTICUT ONE IS SARGENT & COMPANY AT NEW HAVEN. AT WASHINGTON, NEW HAMPSHIRE, WAS OWNED A SAW MILL PROPERTY WHERE THE BEECH BOARDS FOR THE BACKS OF HAND CARDS WERE MADE. THE NEW YORK FACTORY MAY REFER TO SOME SMALL ASSEMBLY OR REPAIR JOB THAT WAS AT THE STORE. WHAT THE VERMONT FACTORY WAS YE EDITOR DOES NOT KNOW. THE 1866 CATALOGUE TITLE PAGE CERTAINLY GIVES THE IMPRESSION OF FIVE SIZABLE FACTORIES, WHEREAS THERE REALLY WERE ONLY TWO. THE SALES ORGANIZATION (I.E. SARGENT & CO., NEW YORK) NEVER INTENTIONALLY PRINTED SOMETHING THAT WAS NOT FACTUALLY CORRECT, BUT DID NOT HESITATE TO CAPITALIZE ON ANY FACTS THAT WOULD HELP SALES. IN THE 1869 CATALOGUE ONLY FACTORIES IN MASSACHUSETTS AND CONNECTICUT ARE MENTIONED—THE NEW HAMPSHIRE, VERMONT AND NEW YORK FACTORIES BY THAT YEAR HAD VANISHED.

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION, WROTE THE FOLLOWING LETTER FROM NEW HAVEN TO HIS WIFE, WHO WAS CONVALESCING IN DR. WARD'S PRIVATE HOSPITAL IN NEW YORK. THE PRESIDENTIAL ELECTION HAD TAKEN PLACE, BUT IT WAS NOT YET KNOWN THAT CLEVELAND HAD DEFEATED BLAINE. THE BUILDING REFERRED TO WAS SARGENT & COMPANY'S BUILDING S, PRIMARILY TO BE USED TO MANUFACTURE THE COMPANY'S NEW LOCK LINE. "NEW HAVEN, NOV. 11, 1884. DEAR FLORENCE: YOU SEE BY THIS THAT I ARRIVED HOME FROM NEW YORK. THERE WAS NOTHING PARTICULARLY INTERESTING ON THE TRIP HOME EXCEPT THAT I CAUGHT COLD IN MY HEAD, MY NECK AND MY NOSE, BY SITTING UNDER THE OVERHEAD VENTILATING WINDOWS IN THE ROOF OF THE CAR AS ALL THE NEW CARS HAVE THEM. HEREAFTER I SHALL HOLD AN OPEN UMBRELLA OVER MY HEAD. WHEN I ARRIVED HOME IT WAS ABOUT 6-30 AND I PROPOSED GOING TO FANNIE'S TO DINNER ALTHOUGH I KNEW I WAS HALF AN HOUR LATE. LAURA ADVISED NOT AND I SUPPED AT HOME AND WENT TO FANNIE'S SOON AFTER. JUST AS I WAS GOING IN PROF. SILLIMAN WAS PREPARING TO COME OUT. HE HAD BEEN THERE TO A 5 O'CLOCK DINNER. MRS. MORSE AND HER TWO DAUGHTERS WERE THERE AND PROF. SILLIMAN IS A COUSIN AND HAD BEEN INVITED TO DINE WITH THEM. SO IF I HAD GONE THERE TO DINNER I SHOULD HAVE BEEN AN HOUR LATER THAN HALF THROUGH DINNER. MRS. MORSE LIVES ON PARK AVENUE, BUT I DID NOT INQUIRE EXACTLY WHERE BECAUSE I DID NOT CARE TO EXHIBIT TOO MUCH FAMILIARITY WITH THAT AVENUE. MR. MORSE IS THE OWNER OF THE MORSE BUILDING, ONE OF THOSE TEN STORY DOWN TOWN BUSINESS OFFICE BUILDINGS. SHE MAY BE ONE OF THE MANAGERS OF YOUR INSTITUTION, AND MAY HAVE TOLD CHARLOTTE. ASK THE DR. I REMAINED TILL 9 O'CLOCK OR MORE AND HAD A VERY PLEASANT EVENING. MRS. MORSE IS AN "INDEPENDENT" AND WE AGREED NICELY ON POLITICS AND BLAINISM IN PARTICULAR. WHEN MR. BLAINE WAS AT MR. THOS. R. TROWBRIDGE'S, TWO OR THREE DAYS BEFORE ELECTION, PROF. SILLIMAN WAS TOO ILL TO CALL ON HIM, AND SENT A NOTE OF REGRETS. MR. HOTCHKISS IS A BLAINITE (AND MRS. HOTCHKISS ALSO) SO

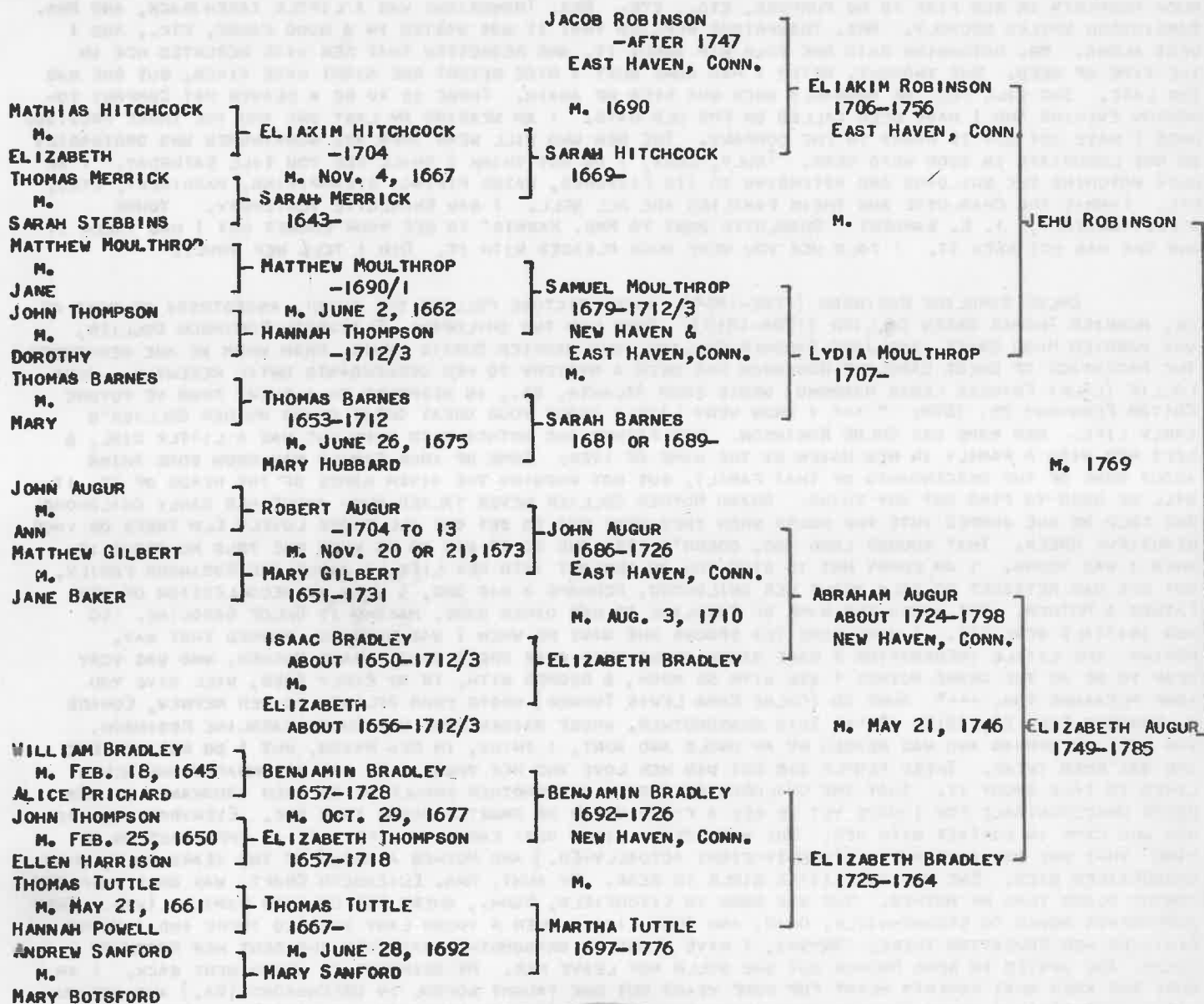


THAT MRS. MORSE HAD NO OPPORTUNITY TO TALK ON BLAINISM TILL SHE MET ME. MY THROAT WAS A LITTLE SOREISH AND ROUGH LAST EVENING AND I TOOK BELLADONNA THROUGH THE NIGHT. WAS BETTER THIS MORNING, BUT WENT TO FACTORY AT 6-45 INTENDING TO REMAIN THERE ONLY AN HOUR OR SO, BUT I DID NOT LEAVE TILL 12-45. I AM ABOUT OVER MY COLD THIS AFTERNOON BUT THE WEATHER IS SO WARM DAMP AND PENETRATING THAT I THOUGHT I WOULD STAY AT HOME A WHILE AND WRITE THIS LETTER. IT IS 4 O'CLOCK NOW, BUT HORSE IS HARNESSSED FOR ME AND I SHALL GO IN A FEW MINUTES. CONSIDERABLE PREPARATION IS BEING MADE FOR THE JUBILEE OF TOMORROW EVENING., I HOPE THE WEATHER WILL BE PLEASANT AND THAT MR. BLAINE IS NOT ELECTED. THERE SEEMS AS YET NO POSITIVE INFORMATION THAT IS OFFICIAL. I THINK I TOLD YOU ABOUT MY SARSEING MRS THOS. R. TROWBRIDGE. SHE WAS ON THE WALK OPPOSITE OUR ELM ST. GATE AND MRS. CARRINGTON MET HER THERE AND THEY WERE ABOUT TO CONVERSE, WHEN I WAS ABOUT TO CROSS ELM ST. TO THE CORNER OF THE GREEN. I CHANGED MY COURSE AND WENT TO MRS. TROWBRIDGE AND ASKED HER TO PLEASE EXPRESS MY REGRETS TO MR. TROWBRIDGE THAT HE HAD WASTED SO MUCH PROPERTY IN RED FIRE TO NO PURPOSE, ETC., ETC. MRS. TROWBRIDGE WAS A LITTLE TAKEN BACK, AND MRS. CARRINGTON SMILED BROADLY. MRS. TROWBRIDGE REPLIED THAT IT WAS WASTED IN A GOOD CAUSE, ETC., AND I WENT ALONG. MR. HOTCHKISS SAID SHE TOLD HIM ABOUT IT, AND REGRETTED THAT HER WITS DESERTED HER IN THE TIME OF NEED. SHE THOUGHT, AFTER I HAD GONE WHAT A NICE RETORT SHE MIGHT HAVE GIVEN, BUT SHE WAS TOO LATE. SHE WILL TELL ME PROBABLY WHEN SHE SEES ME AGAIN. THERE IS TO BE A BEAVER HAT COMPANY TOMORROW EVENING AND I HAVE BEEN CALLED ON FOR OLD HATS. I AM WEARING MY LAST ONE AND THE THREE PREVIOUS ONES I HAVE GOT OUT TO CARRY TO THE COMPANY. THE MEN WHO WILL WEAR THEM ARE WORKINGMEN WHO ORDINARILY DO NOT LUXURIATE IN SUCH HEAD GEAR. TRULY, LURRY, I DO NOT THINK I SHALL SEE YOU TILL SATURDAY. I AM BUSY WATCHING THE BUILDING AND ATTENDING TO ITS FIXTURES, WATER PIPING, STEAMPING, MACHINERY, ETC., ETC. FANNIE AND CHARLOTTE AND THEIR FAMILIES ARE ALL WELL. I SAW CHARLOTTE YESTERDAY. YOURS AFFECTIONATELY, J. B. SARGENT CHARLOTTE WENT TO MRS. HARRIS' TO SEE YOUR BONNET BUT I HAD TAKEN IT AND SHE HAS NOT SEEN IT. I TOLD HER YOU WERE MUCH PLEASED WITH IT. DID I TELL HER TRULY?"

CHLOE CAROLINE ROBINSON (1782-1864), WHOSE PICTURE FOLLOWS THE CHART, ANCESTRESS OF MOST OF US, MARRIED THOMAS GREEN COLLIER (1784-1810). THEY HAD TWO CHILDREN: ELIZABETH ROBINSON COLLIER, WHO MARRIED HUGH CRAFT, AND JANE GARDNER COLLIER, WHO MARRIED CURTIS LEWIS, FROM WHOM WE ARE DESCENDED. THE PARENTAGE OF CHLOE CAROLINE ROBINSON HAS BEEN A MYSTERY TO HER DESCENDANTS UNTIL RECENTLY. AUNT LOLLIE (LAURA FRANCES LEWIS HAMMOND) WROTE FROM ATLANTA, GA., IN RESPONSE TO A QUERY FROM YE FUTURE EDITOR FEBRUARY 26, 1898: " \*\*\* I KNOW VERY LITTLE ABOUT YOUR GREAT GREAT GRAND MOTHER COLLIER'S EARLY LIFE. HER NAME WAS CHLOE ROBINSON. HER FATHER AND MOTHER DIED WHEN SHE WAS A LITTLE GIRL, & LEFT HER WITH A FAMILY IN NEW HAVEN BY THE NAME OF IVES. SOME OF YOUR FAMILY MAY KNOW SOME THING ABOUT SOME OF THE DESCENDANTS OF THAT FAMILY, BUT NOT KNOWING THE GIVEN NAMES OF THE HEADS OF IT, IT WILL BE HARD TO FIND OUT ANY THING. GRAND MOTHER COLLIER NEVER TALKED MUCH ABOUT HER EARLY CHILDHOOD. SHE TOLD ME SHE JUMPED INTO THE HOLES WHEN THEY WERE DUG TO SET OUT ALL THOSE LOVELY ELM TREES ON YOUR BEAUTIFUL GREEN. THAT SOUNDS LONG AGO, DOESN'T IT? AND SO IT DID TO ME WHEN SHE TOLD ME ABOUT IT, WHEN I WAS YOUNG. I AM SORRY NOT TO GIVE YOU AN INSIGHT INTO HER LIFE, & ABOUT THE ROBINSON FAMILY, BUT SHE WAS RETICENT TO TALK ABOUT HER CHILDHOOD, PERHAPS A SAD ONE, & WITH NO RECOLLECTION OF HER FATHER & MOTHER. SHE ADDED THE NAME OF CAROLINE TO HER OTHER NAME, MAKING IT CHLOE CAROLINE. SO HER INITIALS WERE CCC. I HAVE SOME TEA SPOONS SHE GAVE ME WHEN I WAS MARRIED, MARKED THAT WAY. HOPING THE LITTLE INFORMATION I HAVE GIVEN ABOUT THIS DEAR GREAT GREAT GRAND MOTHER, WHO WAS VERY DEAR TO ME AS THE GRAND MOTHER I WAS WITH SO MUCH, & ROOMED WITH, IN MY EARLY DAYS, WILL GIVE YOU SOME PLEASURE TOO. \*\*\*" AUNT CO (CHLOE EMMA LEWIS TURNER) WROTE FROM ATLANTA TO HER NEPHEW, EDWARD R. SARGENT, FEB. 22, 1912: " \*\*\* THIS GRANDMOTHER, WHOSE MAIDEN NAME WAS CHLOE CAROLINE ROBINSON, WAS LEFT AN ORPHAN AND WAS REARED BY AN UNCLE AND AUNT, I THINK, IN NEW HAVEN, BUT I DO NOT BELIEVE SHE WAS BORN THERE. THESE PEOPLE DID NOT WIN HER LOVE AND HER YOUNG LIFE WAS SO UNHAPPY SHE NEVER LIKED TO TALK ABOUT IT. THAT THE CHILDREN OF SUCH A GRANDMOTHER SHOULD BE IN SUCH IGNORANCE OF HER SEEMS UNACCOUNTABLE FOR I HAVE YET TO SEE A FINER WOMAN OR SMARTER WOMAN THAN SHE. EVERYBODY ADMIRER HER WHO CAME IN CONTACT WITH HER. SHE WAS LEFT A WIDOW VERY EARLY IN LIFE. IT IS IMPRESSED ON MY MIND THAT SHE WAS TWENTY-FIVE, (TWENTY-EIGHT ACTUALLY-ED.) AND MOTHER A CHILD OF TWO YEARS ONLY, WHEN GRANDFATHER DIED. SHE HAD TWO LITTLE GIRLS TO REAR. MY AUNT, MRS. ELIZABETH CRAFT, WAS ONLY THIRTEEN MONTHS OLDER THAN MY MOTHER. SHE WAS BORN IN LITCHFIELD, CONN., WHERE THE COLLIER FAMILY LIVED. THEY AFTERWARDS MOVED TO STEUBENVILLE, OHIO, AND AUNT LIZZIE WHEN A YOUNG LADY VISITED THERE AND I THINK FINISHED HER EDUCATION THERE. ANYWAY, I HAVE HEARD MY GRANDMOTHER SAY THAT SHE SENT HER NORTH TO SCHOOL AND WANTED TO SEND MOTHER BUT SHE WOULD NOT LEAVE HER. MY GRANDMOTHER NEVER WENT BACK. I AM SURE SHE KNEW WHAT POVERTY MEANT FOR SOME YEARS BUT SHE TAUGHT SCHOOL IN GREENSBORO (GA.) AND ACCUMULATED CONSIDERABLE MONEY THROUGH GOOD INVESTMENTS. MY MOTHER'S MARRIAGE WAS ROMANTIC. SHE MUST HAVE BEEN VERY ATTRACTIVE AND HAD MANY SUITORS. MY FATHER (CURTIS LEWIS) WAS NOT IN FAVOR WITH MY GRANDMOTHER BECAUSE HE WAS POOR AND BECAUSE SHE KNEW SO WELL WHAT THAT MEANT SHE WANTED TO SPARE HER CHILD THE HARDSHIPS SHE HAD KNOWN. AS A DUTIFUL CHILD MOTHER TRIED TO LOVE THE MAN GRANDMOTHER LIKED. SHE WAS ONLY EIGHTEEN. FATHER WAS HANDSOME AND DETERMINED TO WIN HER WHICH HE DID AND THAT IS WHY THE LICENSE WAS SAFE IN HIS POCKET SOME DAYS BEFORE THE MARRIAGE AND GRANDMOTHER HAD TO DO WHAT MANY A MOTHER HAS HAD TO DO—FORGIVE AND FORGET—(WHICH SHE WAS SOME TIME DOING, BUT SHE FINALLY BECAME VERY FOND OF MY FATHER). \*\*\*" JACOBUS' "FAMILIES OF ANCIENT NEW HAVEN", VOL. 6 (1929-30), STATES THAT CHLOE ROBINSON, THE SIXTH OF THE SEVEN CHILDREN OF JEHU AND ELIZABETH AUGUR ROBINSON, WAS BAPTIZED NOVEMBER 3, 1782, IN CENTER CHURCH (FIRST CONGREGATIONAL CHURCH) IN NEW HAVEN, OF WHICH REV. CHARLES WHITTLESEY WAS PASTOR. SHE WAS NAMED FOR A SISTER CHLOE, WHO WAS BAPTIZED IN CENTER CHURCH OCTOBER 2, 1774, AND DIED APRIL 2, 1782. (THE CHURCH RECORDS SHOW THE FIRST CHLOE DIED "SUDDENLY" AGED 8, AND WAS THE

DAUGHTER OF "CAPT." JEHU ROBINSON.) JEHU WAS THE FOURTH OF THE SIX CHILDREN OF ELIAKIM ROBINSON OF EAST HAVEN, CONN. THE DATES OF BIRTH AND DEATH OF JEHU HAVE NOT BEEN FOUND. HE WAS MARRIED IN 1769 (ACCORDING TO THE RECORDS OF THE CONGREGATIONAL SOCIETY IN EAST HAVEN) TO ELIZABETH AUGUR, THE SECOND OF SEVEN DAUGHTERS OF ABRAHAM AND ELIZABETH (BRADLEY) AUGUR, WHO ALSO HAD ONE SON. ELIZABETH AUGUR WAS BAPTIZED (ACCORDING TO THE RECORDS OF THE CONGREGATIONAL SOCIETY, WOODBRIDGE, CONN.) JUNE 11, 1749, AND DIED JULY 19, 1785, AGED 37, OF CONSUMPTION (ACCORDING TO CENTER CHURCH RECORDS) AFTER THE BIRTH OF HER SEVENTH CHILD. A YOUNGER SISTER LYDIA AUGUR (1754-1802) MARRIED APRIL 22, 1772, DR. LEVI LIVES, OBVIOUSLY THE AUNT AND UNCLE WHOSE WARD CHLOE ROBINSON BECAME. THE ANCESTRY OF THE LATTER WHO DIED IN HOLLY SPRINGS, MISS., JANUARY 21, 1864, IS SHOWN ON THE FOLLOWING CHART, (SEE ALSO THE CHART IN SARGENTRIVIA OF FEBRUARY 24, 1949.) IN ADDITION TO JACOBUS' "NEW HAVEN" AND THE RECORDS OF CENTER CHURCH, NEW HAVEN, REFERENCES ARE DODD'S "EAST HAVEN", AND GENEALOGIES OF THE FAMILIES OF AUGUR, HITCHCOCK, MERRICK AND TUTTLE.
