SARGENT & COMPANY HAS HAD AN UNUSUALLY LOW RECORD OF FIRES. NEW BUILDINGS IN NEW HAVEN WERE FIRST OCCUPIED IN 1864. IT WAS FIFTY YEARS, IN 1914, BEFORE THE FIRST CLAIM WAS MADE UNDER ITS FIRE INSURANCE POLICIES, AND THAT WAS FOR WINDSTORM DAMAGE AMOUNTING TO ABOUT \$2,000. THE FIRST CLAIM FOR FIRE DAMAGE WAS FOUR YEARS LATER, IN 1918, FOR APPROXIMATELY \$1,900. THE TOTAL OF ALL CLAIMS UNDER THE FIRE INSURANCE POLICIES PAID PRIOR TO THE WINDSTORM OF NOVEMBER 25, 1950, WAS \$27,030.15. AS AN INDICATION OF THE SEVERITY OF THAT ONE STORM OF NOVEMBER 25, 1950, IT CAUSED CLAIMS FOR WINDSTORM DAMAGE OF \$27,406.68, OR MORE THAN THE TOTAL OF ALL FIRE AND WINDSTORM CLAIMS FOR THE PREVIOUS 86 YEARS.

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION, WROTE THE FOLLOWING LETTER TO HIS WIFE WHO WAS VACATIONING IN LAKEWOOD, N.J., WITH HER BROTHER-IN-LAW AND SISTER FANNY, MR. AND MRS. JUSTUS S. HOTCHKISS. "J.B." WAS A STRONG FREE TRADER BUT APPARENTLY HAD NOT BEEN ABLE TO WIN HIS BROTHER-IN-LAW TO THAT BELIEF.

"NEW HAVEN, 6 P.M., WEDNESDAY, MARCH 20/95

DEAR FLORENCE:

"I HAVE BEEN IN NEW YORK TODAY AND RETURNED ON THE 1 P.M. TRAIN. I WAS RATHER LATE BUT I FOUND ONE SEAT ENTIRELY VACANT. AS I ENTERED THE SEAT A LADY, WHO SAT ALONE IN THE SEAT NEXT BEHIND THE SEAT I WAS TO TAKE, ACCOSTED ME WITH A 'HOW-DI-DOO'. SHE WAS AN OLD ACQUAINTANCE NAMED LAURA SARGENT. SO I SAT AT HER SIDE ALL THE WAY TO NEW HAVEN. I HAD A ROLL OF BREAD AND BUTTER IN MY POCKET WHICH WAS ABOUT ALL I GOT OF A 35 CT. ROAST BEEF LUNCH AT FUSSELL'S. LAURA HAD BEEN THERE JUST BEFORE ME AND GOT A SANDWICH WHICH SHE ATE IN THE CAR BEFORE I ENTERED. MISS JENNINGS IS GONE TO PHILA.

"TELL MR. HOTCHKISS THAT MY OPINION IS THAT WHEN PEOPLE SAY IT MAKES BUSINESS GOOD TO HAVE IRON, STEEL, BREADSTUFFS, ETC. HIGH IN PRICE, THEY PUT THE CAUSE FOR THE EFFECT OR RATHER THE EFFECT FOR THE CAUSE. WHEN, AFTER A LONG CONTINUED PERIOD OF STAGNATION THAT IS SURE TO FOLLOW A PERIOD OF UNNATURAL, ARTIFICIAL AND HIGH TARIFF FEVERED BUSINESS ACTIVITY, - WHEN THE OVERSTOCKED HOME MARKET BECOMES QUITE BARE OF GOODS THAT PERHAPS HAVE BEEN SOLD AT COST OR LESS, AND FOR LACK OF DEMAND, THE RAW MATERIALS HAVE FALLEN VERY LOW IN PRICE, AND FARMERS HAVE NEGLECTED TO RAISE LARGE CROPS BE CAUSE EVERY HAS BEEN PRACTICING ENFORCED ECONOMY, AND FOREIGN NATIONS WOULD NOT BUY OUR BREADSTUFFS AND COTTON BECAUSE OUR TARIFFS ARE SO HIGH THAT WE CANNOT BUY FROM THEM - THEN UNDER SUCH CIRCUMSTANCES MANY PEOPLE, MAINLY THE PROTECTIONISTS PRAY FOR HIGH PRICED BREAD STUFFS, HIGH PRICED MEATS, HIGH PRICED PIG AND BAR IRON AND STEEL, HIGH PRICED COAL, HIGH PRICED WOOD AND HIGH PRICED LIVING FOR POOR AND RICH. BUT THEY GET THE CART BEFORE THE HORSE AND TRY TO MAKE THE CART DRAW THE HORSE. HIGHER PRICES IS THE RESULT OF AN INCREASING DEMAND OF THE RAW MATERIALS OF MANUFACTURE AND OF BREAD AND MEAT FOR THE WORKMEN AND MECHANICS TO EAT AFTER THEY GET WORK AND WAGES.

"THE BEST CONDITION FOR A COUNTRY TO BE IN IS THAT OF ABUNDANT AND LOW COST FOOD SUPPLIES, ABUNDANT AND LOW COST RAW MATERIALS FOR MANUFACTURES AND WHEN IN THAT CONDITION THE INDUSTRIAL SITUATION UNDER FREEDOM OF TRADE IS PERFECT. UNDER SUCH CIRCUMSTANCES A COUNTRY THAT MANUFACTURES CAN EXPORT ITS GOODS TO AGRICULTURAL COUNTRIES AND TO TROPICAL COUNTRIES AND BRING BACK IN PAYMENT THE PRODUCTIONS OF THOSE COUNTRIES.

"LOW PRICED RAW MATERIALS AND PROVISIONS FOR FOOD ARE THE FOUNDATION STONES OF SUCCESSFUL MANUFACTURES, BUT AFTER MANUFACTURING AND CONSEQUENT TRANSPORTATION BECOMES BRISK AND THE RAW MATERIALS ARE LARGELY DEMANDED FOR USE THEN PRICES OF THEM ADVANCE UNLESS THE SUPPLY KEEPS UP WITH THE INCREASING SUPPLY, UNTIL THE COUNTRY BECOMES FULLY SUPPLIED AND OVERSTOCKED WITH GOODS, AND PROTECTIONISTS PUT SO HIGH A TARIFF ON RAW MATERIALS THAT THEY CANNOT BE IMPORTED. WHEN THEY CANNOT BE IMPORTED FREE OF DUTY SO THAT WE CAN COMPETE IN THE MANUFACTURES WITH THE MANUFACTURERS OF ENGLAND AND GERMANY, THEN, IF OUR OWN COUNTRY HAS ALL THE GOODS IT CAN CONSUME THE DULL TIMES WILL SURELY COME.

"WHEN THERE IS A LARGE DEMAND FOR MANUFACTURED GOODS THE RAW MATERIALS BEGIN TO ADVANCE. LABOR GETS MORE AND HIGHER WAGES AND EATS VERY MUCH MORE PROVISIONS AND THEY ADVANCE IN PRICE AND BUSINESS IS BRISK IN ALL THE DEPARTMENTS. DONT BE FOOLED BY THE SOPHISTRY OF THOSE PROTECTIONISTS WHO EXPECT A CART TO DRAW THE HORSE.

"LEWIS IS EXPECTED TONIGHT. ALL WELL HERE. MISS WINCHESTER, LAURA, MAY AND I GO TOGETHER TO THE CONCERT TONIGHT. NELLIE GOES WITH ANOTHER PARTY.

REMEMBER ME TO FANNY AND JUSTUS."

PETER MILLS (1622-1710), IMMIGRANT ANCESTOR OF MOST OF US, WAS THE ELDEST SON OF SIR PETER WOUTERS VAN DER MEULEN OF AMSTERDAM, HOLLAND. SIR PETER'S KNIGHTHOOD WAS CONFERRED UPON HIM FOR DISTINGUISHED SERVICES TO THE PUBLIC IN THE IMPROVEMENT OF DYKES AND CANALS. YOUNG PETER ABOUT 1650 JOINED AT LEYDEN, HOLLAND, THE ENGLISH REFUGEES WHO HAD COME THERE FOR CONSCIENCE'S SAKE, WHICH AROUSED THE DISPLEASURE OF HIS FATHER, WHO DISINHERITED HIM. AT THE TIME HE EMIGRATED TO AMERICA HE WAS STUDYING FOR THE MINISTRY AT LEYDEN UNIVERSITY. HE CAME TO THE COLONY OF CONNECTICUT, WHOSE RECORDS (VOL. 1) SHOW THAT BY HIS OWN REQUEST HIS NAME WAS CHANGED TO PETER MILLS, VAN DER MEULEN BEING IN DUTCH "THE MAN OF THE MILL". HE MARRIED FIRST DORCAS (OR DORKAS) MESSINGER, DAUGHTER OF EDWARD MESSINGER. THE LATTER IN 1666 GAVE HIS DUTCH SON-IN-LAW TWENTY ACRES OF HIS GREENFIELD (NOW BLOOMFIELD) LAND TO BUILD UPON. (THE COURT RECORDS SHOW THAT ON ONE OCCASION EDWARD MESSINGER WAS SENTENCED TO BE WHIPPED "FOR HIS UNMERCIFULNESS TOWARDS HIS SERVANT AND HIS LYING TO EXTENUATE HIS FAULT.") DORCAS WAS BORN SEPTEMBER 23, 1650, AND WAS THEREFORE ABOUT 28 YEARS HER HUSBAND'S JUNIOR. SHE DIED MAY 18, 1688. HE MARRIED SECONDLY JANE WARREN OF HARTFORD ON DECEMBER 10, 1691. HE HAD A LOT IN HADDAM, THOUGH HE IS NOT KNOWN TO HAVE LIVED THERE. THE TOWN OF HADDAM VOTED MARCH 13, 1670, TO THOMAS SHAILLER "THE LOTE THAT WAS PETER MILESE'S THE DOUCHEMANES". HE LIVED IN WINDSOR IN CONNECTICUT COLONY AND HIS OCCUPATION WAS A TAILOR. HE APPARENTLY NEVER COMPLETED HIS STUDIES FOR THE MINISTRY. STILES' "HISTORY AND GENEALOGIES OF ANCIENT WINDSOR, CONN." (1892), FROM WHICH THE ABOVE INFORMATION HAS BEEN GLEANED, STATES THAT "AS A TAILOR, HE IS FREQUENTLY MENTIONED IN M.S. OF REV. TIMOTHY EDWARDS OF (EAST) WINDSOR". HE AND DORCAS HAD FOUR CHILDREN, TWO OF WHOM DIED IN THEIR YOUTH. WE ARE DESCENDED FROM PETER, JR., WHOSE DAUGHTER, ANN, MARRIED DAVID BOOTH (SEE GENEALOGICAL CHART IN SARGENTRIVIA OF SEPTEMBER 26, 1950, IN WHICH THE MARRIAGE OF PETER, JR. WAS INCORRECTLY GIVEN AS IN 1792, SHOULD HAVE BEEN 1692).
