HEATH'S VACATION FELL DUE WHEN I RETURNED HOME FROM THE HOSPITAL, AND I THINK THAT HE WILL BE GOING BACK TO WORK TO REST! OUR THREE LITTLE INDIANS KEEP US JUMPING. . . ." THE BUMGARDNERS LIVE AT 415 EAST DURHAM STREET, PHILADELPHIA 19, PA.

ENSIGN MICHAEL M. GROVE, SON OF BARBARA SARGENT MOOREHEAD, WROTE ON FEBRUARY 17TH: "I'M AFRAID I HAVE LITTLE TO OFFER IN RESPONSE TO YOUR REQUEST FOR MY EXPERIENCES. HOWEVER, I WILL TRY TO BRING YOU UP TO DATE ON MY WANDERINGS SINCE THE SPRING OF 1950. UPON GRADUATION FROM THE NAVAL ACADEMY I WAS ASSIGNED TO THE U.S.S. RENSHAW (DDE499) WHICH WAS BEING RECOMMISSIONED AND CONVERTED AT NORFOLK. ORIGINALLY SHE WAS A GENERAL PURPOSE DESTROYER OF THE FLETCHER CLASS, DISPLACING 2,100 TONS, BOASTING MUCH SPEED, BUT LITTLE COMFORT. SHE HAD A FINE RECORD IN THE PACIFIC, AMONG OTHER THINGS, HAVING SURVIVED A TORPEDO HIT. AT THE END OF THE WAR SHE WAS MOTHBALLED UNTIL SHE WAS DRAWN FROM THE RESERVE FLEET FOR CONVERSION TO AN ESCORT DESTROYER LATE IN 1949. AN ESCORT DESTROYER IS BUILT PRIMARILY FOR ANTI-SUBMARINE WARFARE. SHORTLY AFTER I REPORTED ABOARD, THE KOREAN WAR BROKE OUT, AND THE CONVERSION WAS SPEEDED UP. SINCE THE RENSHAW'S HOME PORT WAS TO BE PEARL HARBOR, WE ALL REASONED THAT WE WOULD BE SENT WEST AS SOON AS POSSIBLE. THEY TRIED TO SEND US. WE MADE OUR DEPARTURE FROM THE EAST COAST IN AUGUST AND PROCEEDED AT MAXIMUM SPEED THROUGH THE PANAMA CANAL TO SAN DIEGO. THERE I SAW JIM. HE HAD COMMAND OF THE U.S.S. CURLEW (AMSB). AFTER A FEW BRIEF VOYAGE REPAIRS, WE RUSHED TO PEARL HARBOR, WHERE OUR ENGINEERING PLANT GAVE OUT UNDER THE STRAIN. ALTHOUGH WE CARRIED SOME OF THE LATEST OPERATIONAL ASW DEVICES, WE HAD THE SAME OLD BOILERS AND ENGINES THAT WERE ORIGINALLY BUILT INTO THE SHIP.

"BY THE TIME WE WERE READY TO PROCEED ANOTHER DESTROYER HAD BEEN ASSIGNED OUR DUTY. SO WE REMAINED IN PEARL HARBOR UNTIL JUNE 1951, TRAINING. WHILE THE RENSHAW WAS AT PEARL, THE CURLEW WAS SENT WEST, AND I ENTERTAINED JIM, AS HE PASSED THROUGH. THE SHOE WAS ON THE OTHER FOOT. FINALLY, LAST JUNE, WE LEFT FOR KOREAN WATERS. TRUE TO OUR DESIGNATION, ESCORT DESTROYER, WE ESCORTED OUR OWN BATTLESHIPS, CRUISERS, AND CARRIERS, AS WELL AS THOSE OF THE OTHER UNITED NATIONS.

"I WAS KEPT BUSY AS CIC OFFICER. CIC IN THE NAVY STANDS FOR COMBAT INFORMATION CENTER, A SMALL DARKENED ROOM FULL OF ELECTRONIC GEAR USED FOR THE DETECTION OF THE ENEMY AND HIS MOVEMENTS, AS WELL AS KEEPING TRACK OF OUR OWN FORCES. I WAS IN CHARGE OF THE MEN AND EQUIPMENT INCLUDED IN AND ASSOCIATED WITH CIC. MY BATTLE STATION WAS IN CIC ASSISTING THE EXECUTIVE OFFICER BY PRESENTING A VISUAL DISPLAY OF ALL THE INFORMATION MY GEAR AND MEN WOULD GATHER. THE EXEC. WOULD THEN EVALUATE THIS INFORMATION AND PASS THE IMPORTANT PART ON TO THE CAPTAIN. FOR A WHILE IT LOOKED AS IF WE WERE GOING TO SPEND OUR ENTIRE TIME ESCORTING THE HEAVY SHIPS. HOWEVER WE FINALLY RECEIVED ORDERS TO GO IN AND DO SOME SHORE BOMBARDMENT. WE ENCOUNTERED LITTLE OPPOSITION, BUT WE ALL FELT WE WERE CONTRIBUTING A LITTLE MORE TO THE WAR EFFORT THAN WE HAD WHILE ESCORTING. AS USUAL, THE OPPOSITION CAME UNEXPECTEDLY. I HAD JUST RETIRED FROM A 6 HOUR WATCH CONDUCTING INTERDICTION FIRE FROM MIDNIGHT TO DAWN. MY FIRST REACTION TO THE GENERAL ALARM WAS THAT IT WAS ANOTHER DRILL. SOMEONE SAID 'THEY'RE SHOOTING AT US'. IT WAS NO DRILL. BY THE TIME I GOT TO CIC OUR COUNTER BATTERY FIRE HAD NEUTRALIZED THE SHORE BATTERY THAT HAD OPENED UP ON US. WE KNOCKED ONE GUN OUT OF IT'S EMPLACEMENT AND DOWN A BLUFF NEAR THE WATER'S EDGE. WHETHER THE GUN ACTUALLY WENT INTO THE WATER IS A MATTER OF CONJECTURE, BUT WE WERE OFFICIALLY CREDITED WITH THE SINKING OF ONE SHORE BATTERY. A BRITISH HISTORIAN CLAIMS THAT IT WAS THE FIRST SHORE BATTERY TO BE SUNK IN THE TRUE SENSE OF THE WORD. ON OUR SIDE WE RECEIVED MINOR DAMAGE FROM SHRAPNEL, AND ONE MINOR PERSONNEL CASUALTY. ALTHOUGH OTHER SHIPS NEAR US WERE FIRED UPON, WE NEVER CAME UNDER FIRE AGAIN. WE LEFT THE KOREAN AREA ON THE FIRST OF NOVEMBER.

"WHILE IN WESTERN WATERS WE WOULD RETURN TO YOKOSUKA, JAPAN, TO UNDERGO MINOR REPAIRS AND OVERHAUL. DURING ONE OF OUR STAYS, IN AUGUST, I RAN INTO JIM. THE CURLEW WAS UNDERGOING EXTENSIVE OVERHAUL IN DRYDOCK, AND THAT GAVE US A CHANCE TO SPEND ALMOST A WEEK TOGETHER AT A REST CAMP IN THE JAPANESE MOUNTAINS, ABOUT 250 MILES WEST OF TOKYO. WE TRAVELLED BY RAIL FROM TOKYO, AN EIGHT HOUR RIDE WINDING THROUGH MOUNTAINS AND VALLEYS. IT GAVE ME A CHANCE TO SEE RURAL JAPAN. WE STAYED AT THE AKAKURA IMPERIAL HOTEL, A FABULOUS SKI RESORT ALONG SWISS LINES. THERE WAS NO SNOW, BUT WE PLAYED TENNIS, SAILED, SWAM, AND AQUAPLANED. A PLEASANT CHANGE FROM SHIPBOARD ROUTINE. WE RETURNED TO TOKYO BY SLEEPER. THE BUNKS WERE BUILT FOR THE JAPANESE, AND WERE A BIT SHORT. WHEN THE RENSHAW RETURNED TO PEARL HARBOR I RECEIVED MY ORDERS TO SUBMARINE SCHOOL. ON THE 28TH OF NOVEMBER I STARTED EAST. I ARRIVED HOME FOR CHRISTMAS, AND ON THE 1ST OF JANUARY, REPORTED FOR DUTY HERE AT NEW LONDON. THAT BRINGS YOU MORE OR LESS UP TO DATE. WHAT DUTY I GET IN JUNE, UPON GRADUATION, DEPENDS UPON MANY FACTORS, INCLUDING MY ACADEMIC PROFICIENCY. HOWEVER, I WILL BE ASSIGNED TO A SUBMARINE.

"BEING SO CLOSE TO NEW HAVEN I HOPE TO BE ABLE TO GET DOWN SOME WEEKEND AND SAY HELLO." MIKE'S ADDRESS IS ENSIGN MICHAEL M. GROVE, U.S.N., BOX 7, U.S. NAVAL SUB BASE, NEW LONDON, CONN.

STEVIA W. SARGENT, DAUGHTER OF J. WEIR SARGENT, AND A FRESHMAN AT MOUNT HOLYOKE COLLEGE, WROTE HER PARENTS ON FEBRUARY 10TH: "LAST MONDAY (FEBRUARY 4TH) REALLY GOT TO WORK ON THE SONG. NOW I'LL TRY TO EXPLAIN WHAT THE CONTEST WAS. IT WAS CALLED A SONG FEST. EACH DORM ON THE CAMPUS WERE TO SING A SONG. THE SONGS HAD TO HAVE SOMETHING TO DO WITH HOLYOKE COLLEGE LIFE. I WAS ELECTED THE SONG COMMITTEE HEAD OF SAFFORD AND, AS SUCH, WAS RESPONSIBLE FOR GETTING OUR CONTRIBUTION READY. ANY NUMBER OF GIRLS COULD SING FROM YOUR DORM AND HARMONY, ETC., WERE ALLOWED. WELL, AFTER PERSUASION FROM THE PEOPLE HERE IN SAFFORD, I DECIDED TO USE THAT MARCH THAT I MADE UP AT CHRISTMAS. ON MONDAY NIGHT I CHOSE FOUR GIRLS TO HELP ME WITH THE WORDS. WE WORKED LIKE BEAVERS TRYING NOT TO USE OLD CLICHES SUCH AS 'ALWAYS BE TRUE TO YOU,' 'WE LOVE THEE,' ETC. IT TOOK US A HALF-HOUR TO EVEN GET A FEW LINES BUT AFTER THAT THEY CAME MORE QUICKLY. BY TEN THAT NIGHT THEY WERE ALL DONE AND THOSE SAME PEOPLE WERE SINGING THEM MUCH TO MY JOY. HOW WONDERFUL IT FEELS TO HAVE SOMEONE SING YOUR OWN SONG. WELL, AFTER MONDAY WE HAD ABOUT FIVE REHEARSALS; HAD TO TYPE UP THE WORDS FOR EVERYONE AND GET THEM TO LEARN NOT ONLY THE TUNE BUT ALSO THE SONG. WE DECIDED THAT THE WHOLE DORM SHOULD BE IN IT AND ALL BUT TEN ACTUALLY WERE. IN OTHER WORDS, FIFTY-SIX SANG. THE GIRLS WERE ALL TERRIFIC, TAKING MY CRITICISM SERIOUSLY AND REALLY WORKING HARD. I WORKED OUT AN ALTO FOR IT. ALSO A HIGH SOPRANO IN THE END. THEN DIVIDED THESE FIFTY-SIX INTO FOUR GROUPS ACCORDING TO PART, VOICE, HEIGHT AND THEN LABELED THEM BY COLORS—RED, BLUE, YELLOW AND GREEN, THE CLASS COLORS OF HOLYOKE. ON FRIDAY NIGHT THE FEST TOOK PLACE IN CHAPIN AUDITORIUM—WHAT A NERVE WRECKING TIME. I PLAYED THE PIANO AND THEY REALLY SANG WELL—MADE ME FEEL SORT OF PROUD. WE WERE FIFTH ON THE LIST OUT OF FIFTEEN. WELL, AFTER WE SANG I WOULD LISTEN INTENTLY TO ALL THE OTHER SONGS, ESPECIALLY THE ORIGINAL ONES AND IF I THOUGHT THAT THEY WERE GOOD WOULD SAY 'OH, OH, THEY'RE TERRIFIC' AND ALL THE OTHER SAFFORDITES AROUND ME WOULD LAUGH AND SMILE AND SAY THAT OURS WAS STILL BEST (THAT IS ONE THING THAT GAVE ME A QUEER FEELING—THEIR ABSOLUTE FAITH IN OUR SONG) BUT THEN CAME A SONG THAT WAS REALLY BEAUTIFUL—ALMOST LIKE AN ALMA MATER AND ORIGINAL. AFTER THAT, I SAID MY USUAL SAY ABOUT HOW IT WAS WONDERFUL AND NONE OF THE OTHERS COULD GIVE ANY SMILE OF ENCOURAGEMENT! WELL, TO CUT THIS SHORT, THE JUDGES PICKED THREE THAT THEY WANTED TO HEAR OVER AGAIN, OURS BEING ONE OF THOSE. WE WERE ALL SO SCARED, BUT I TRIED TO SAY A FEW WORDS THAT WOULD MAKE THEM RELAX AND HAVE FUN—AND AGAIN THEY SANG WONDERFULLY. FINALLY, IT WAS ANNOUNCED THAT SAFFORD HAD WON—WAS THAT A WONDERFUL MOMENT! ALL OF SAFFORD AND IN FACT THE WHOLE AUDITORIUM SANG A SONG TO ME—THEN I HAD TO GET UP AND GET THE PLAQUE. AFTER THIS, WE ALL WENT TO THE COLLEGE INN, SANG, CAME BACK, MORE SINGING AND CHEERING. WHEN WE GOT BACK TO SAFFORD THERE WAS A TELEGRAM FROM ONE OF THE FRESHMAN DORMS CONGRATULATING ME! ALSO ON FRIDAY NIGHT WE HAD A FEW ALUMNI HERE FOR SUPPER—AND YESTERDAY THE ONE AT WHOSE TABLE I WAS SITTING BEFORE THE FEST SENT ME A DOZEN RED ROSES—WASN'T THAT TERRIFIC? AND I HARDLY KNEW HER, SO THAT'S THAT!"

THE CHILDREN GO TO SUNDAY SCHOOL ALMOST EVERY WEEK, WHICH MEANS A LOT TO THEM, ESPECIALLY TO EMLI-ANN WHO DOESN'T GO TO SCHOOL YET AND FELT RATHER LEFT OUT. THERE ARE ALSO ACCOMMODATIONS IF WE ALL WANT TO GO, WHERE WE CAN LEAVE SPRAGUE, JR., WHO IS AT THE AGE WHERE HE IS INTO EVERYTHING. HE IS JUST AS BLOND AS EVER, QUITE SPOILED DUE TO HIS SISTERS! C. FORBES SARGENT, SON OF GEORGE LEWIS SARGENT, AS PRESIDENT OF SARGENT & COMPANY UNDERGOES A GREAT VARIETY OF EXPERIENCES, BOTH ON THE PLEASING AND ON THE ANNOYING SIDE. IN FEBRUARY OFFICIALS OF SEARS, ROEBUCK & COMPANY, A LARGE CUSTOMER FOR CARPENTERS' PLANES AND OTHER SARGENT PRODUCTS, INSISTED THAT FORBES COME TO CHICAGO, BUT WOULD NOT REVEAL THEIR REASON. NOT KNOWING WHAT KIND OF A SITUATION WOULD HAVE TO BE STRAIGHTENED OUT, IT WAS DECIDED THAT MR. J. BRYER DUFF, VICE PRESIDENT AND GENERAL SALES MANAGER, SHOULD ACCOMPANY FORBES. MR. DUFF THUS DESCRIBED THEIR CHICAGO MEETING: "THIS WAS A VERY DRAMATIC SITUATION AND VERY IMPRESSIVE. FORBES HAD BEEN REQUESTED TO COME TO CHICAGO, AND, AS THEY HAD BEEN PRETTY ROUGH WITH US ON THEIR DELIVERY REQUIREMENTS, WE BOTH FELT THAT A REQUEST SUCH AS THIS WAS TO SCOLD US FOR NOT PERFORMING IN A BETTER MANNER. WHEN WE ARRIVED IN CHICAGO I TRIED TO FIND OUT FROM MR. DYER JUST WHY FORBES WAS PRACTICALLY COMMANDED TO COME TO SEARS' MAIN OFFICE. THE SUSPENSE LASTED UNTIL THE AFTERNOON WHEN MR. DYER CALLED FORBES AND ME TO GO INTO ANOTHER ROOM WITH HIM. WHEN WE ENTERED THE ROOM THE ENTIRE DEPARTMENT WAS SITTING AROUND, AND WE WERE REQUESTED TO SIT AT THE TABLE FACING THE AUDIENCE. THEN MR. DYER STOOD UP AND EULOGIZED SARGENT & COMPANY. HE SAID THAT, GENERALLY SPEAKING, WHEN ONE THOUGHT OF A NEW ENGLAND MANUFACTURER ONE THOUGHT OF AN ANTIQUATED CONCERN THAT WAS NOT AT ALL UP TO DATE. HE SAID THAT SARGENT & COMPANY WAS A STRIKING EXAMPLE OF WHAT COULD BE DONE WITH AN OLD ORGANIZATION WHEN IT IS MODERNIZED. 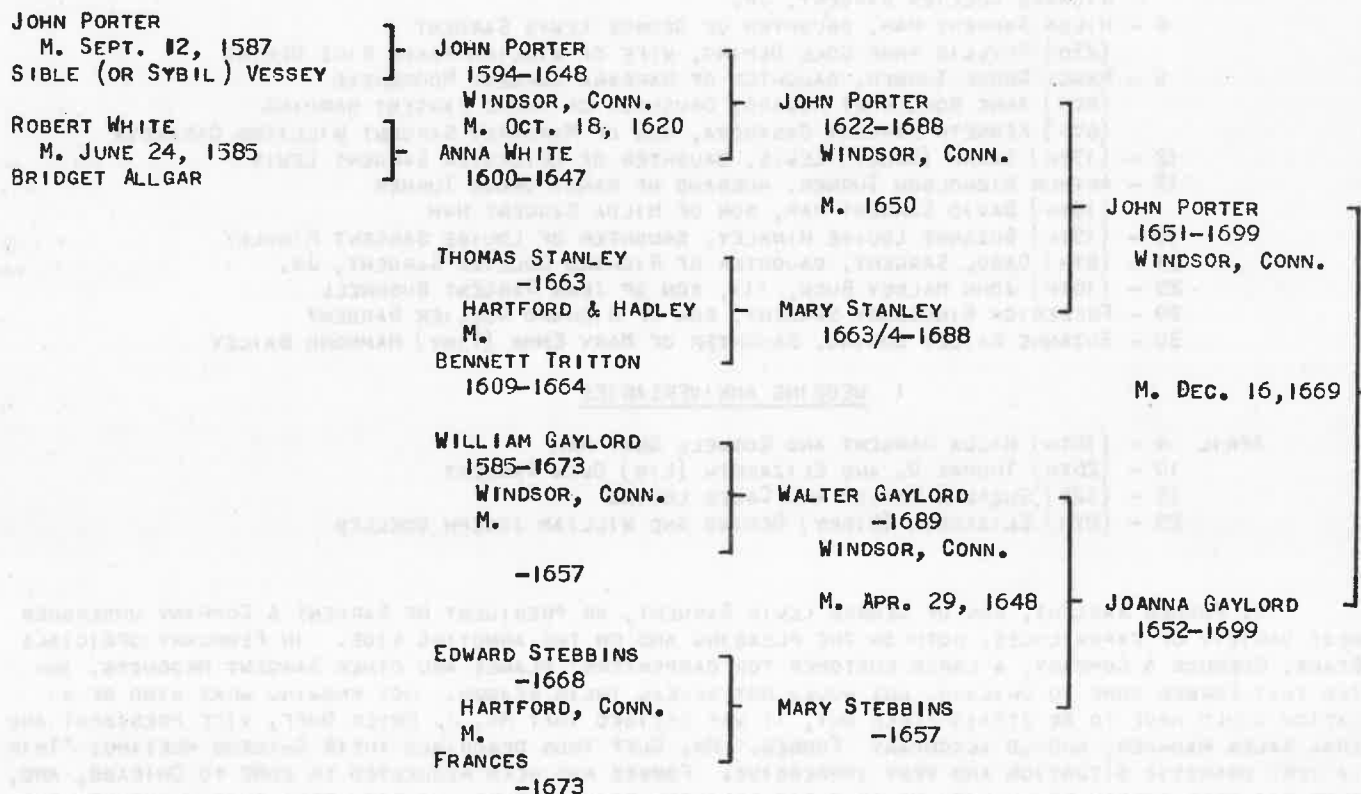
