
RICHARD TREAT (1584-1669/70), ANCESTOR OF MOST OF US, WAS THE FATHER OF JOANNA, WIFE OF LIEUTENANT JOHN HOLLISTER. (SEE GENEALOGICAL CHARTS IN SARGENTRIVIA OF DECEMBER 19, 1950, AND FEBRUARY 24, 1949.) HE WAS BORN IN 1584 IN PITMINSTER, PROBABLY IN THE HAMLET OF SOUTH TRENDLE, NOW IN THE PARISH OF TRULL, SOMERSET, ENGLAND; AND BAPTIZED IN PITMINSTER CHURCH, AUGUST 28, 1584. HE WAS BAPTIZED UNDER THE NAME TROTT, THE SON OF ROBERT AND HONORA (OR HONOUR) TROTT. HE WAS MARRIED, UNDER THE NAME TRETT APRIL 27, 1615, IN PITMINSTER TO ALICE GAYLARD, DAUGHTER OF HUGH. HE WAS IN WETHERSFIELD, CONN., IN 1643, WHEN HE WAS CHOSEN A JUROR AND A GRAND JUROR. HE WAS ELECTED A DEPUTY IN 1644 AND ANNUALLY UNTIL HE WAS ELECTED ASSISTANT, OR MAGISTRATE IN 1657/8 AND ANNUALLY THEREAFTER TO 1665. IN 1644 HE AND Mr. WELLS WERE THE COMMITTEE FROM WETHERSFIELD TO RECEIVE MONEY FOR MAINTAINING SCHOLARS AT CAMBRIDGE. HE SERVED ON VARIOUS OTHER COMMITTEES INCLUDING ONE IN 1663 TO PROCURE A MINISTER. HE WAS NAMED BY CHARLES II AS ONE OF THE PATENTEES IN THE CHARTER GRANTED TO THE CONNECTICUT COLONY IN 1669/70. (HE WAS LIVING OCTOBER II, 1669, AND THE INVENTORY OF HIS ESTATE WAS PRESENTED TO COURT MARCH 3, 1669/70.) HIS ANCESTRY, AS GIVEN IN "THE TREAT FAMILY" BY JOHN HARVEY TREAT (1893) IS OUTLINED AS FOLLOWS:

"FORASMUCH AS IT IS OBSERUED THAT MANY ABUSES ARE CREPT IN AND COMITTED BY FREQUENT TAKING OF TOBACKO, IT IS ORDERED BY THE AUTHORITY OF THIS COURTE, THAT NO PERSON VNDER THE AGE OF TWENTY YEARES, NOR ANY OTHER THAT HATH NOT ALLREADY ACCUSTOMED HIMSELFE TO THE VSE THEREOF, SHALL TAKE ANY TOBACKO, VNTILL HEE HATH BROUGHT A CERTIFICATE VNDER THE HANDS OF SOME WHO ARE APPROUED FOR KNOWLEDGE AND SKILL IN PHISICK, THAT IT IS VSEFULL FOR HIM, AND ALLSO THAT HEE HATH RECEIUED A LYCENSE FROM THE GOURT FOR THE SAME. AND FOR THE REGULATING OF THOSE WHOE EITHER BY THEIRE FORMER TAKING IT HAVE TO THEIR OWNE APREHENSIONS MADE IT NECESSARY TO THEM, OR VPPON DUE ADVICE ARE PERSWADED TO THE VSE THERE-OF, IT IS ORDERED, THAT NO MAN WITHIN THIS COLONYE, AFTER THE PUBLICATION HEREOF, SHALL TAKE ANY TOBACKO PUBLIQUELY IN THE STREET, HIGH WAYES, OR ANY BARNE YARDS, OR VPPON TRAINING DAYES IN ANY OPEN PLACES, VNDER THE PENALTY OF SIX PENCE FOR EACH OFFENCE AGAINST THIS ORDER IN ANY THE PERTICULARS THEREOF, TO BEEPAID WITHOUT GAINSAYING VPPON CONVICTION, BY THE TESTIMONY OF ONE WITTNESS THAT IS WITHOUT JUST EXCEPTION, BEFORE ANY ONE MAGISTRATE, AND THE CONSTABLES IN THE SEVERALL TOWNES ARE REQUIRED TO MAKE PRESENTMENT TO EACH PERTICULAR COURTE OF SUCH AS THEY DOE VNDERSTAND AND EUICT TO BEE TRANS—GRESSORS OF THIS ORDER."

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR AND TWENTY-NINE OTHERS, WROTE THE FOLLOWING LETTER TO HIS WIFE WHO WAS VISITING A SISTER, MRS. SWAN, IN BOSTON. "SARGENT & CO.

NEW HAVEN, CONN., OCT. 19 1886

MY DEAR FLORENCE:

"I HAVE RECEIVED YOUR LETTERS REGULARLY SO THAT I KNOW YOU ARE WELL AND, OF COURSE IF WELL, ARE HAVING A GOOD TIME. IT IS TOO BAD TO MAKE YOU STOP TO READ A LETTER, BUT PERHAPS YOU HAVE NOT HEARD OF EVERYTHING GOING. I WAS IN NEW YORK AT THE BUSINESS MENS TARIFF REFORM MEETING; HAD A LARGE & ENTHUSIASTIC MEETING - GOOD SPEECHES FROM ABLE MEN, AMONG THEM 4 M.CS. AND 1 EX M.C. NEXT DAY ATTENDED A MANUFACTURER'S MEETING AT MURRAY HILL HOTEL, WHERE I TEMPORARILY RESIDED. LAST SATURDAY P.M. I ATTENDED THE LAWN TENNIS CONTEST. WENT OUT WITH LAURA. LOVELY AFTERNOON & WOMEN. GAY TIME SUNDAY P.M. TOOK A DRIVE WITH LAURA. CALLED TO SEE JOHNSTON'S BABY - WHICH IS RATHER BETTER BUT A LONG WAYS FROM FAT. HAVE USED UP EVENINGS IN VARIOUS WAYS, EAT WELL & SLEEP WELL, AND AM BUSY AS I CAN BE AT NOTHING IN PARTICULAR. LEWIS' GRANDMOTHER & FAMILY MOVED IN, AND LEWIS & WIFE MOVED OUT. SHE HAS GONE TO HER FATHERS FOR TWO WEEKS AND SO HAS LEWIS - TO HIS. BREAKFAST AS USUAL. ALL THE FAMILY BUT LEWIS, DAISEY JOHN & I WENT TO THE BALL LAST NIGHT. SAW THEM TODAY AT DINNER. I AM NOT GOING TO BOSTON. ALL WELL.

LUCY HOLLAND PUTNAM, DAUGHTER OF MARY (MINNIE) RUPPERT HOLLAND, RECENTLY MADE A TRIP JO ENGLAND WITH GEORGE, HER HUSBAND, CALLED BY THE SERIOUS ILLNESS OF HIS SISTER MARY PUTNAM DEPREE, WHO DIED BEFORE THEY LEFT THIS COUNTRY. LUCY WROTE TO YE EDITORS, THE LETTER DATED APRIL 5 FROM CHEYNE HOUSE, RYE, SUBSEX, BUT FINISHED APRIL 21 ON THE S.S. CARONIA AND MAILED AT NEW YORK ON THEIR RETURN: "YESTERDAY WE CAME BACK FULL OF WONDER AND ADMIRATION FOR THE ANCIENT CITY OF LONDON. WHEREVER ONE GOES THERE ARE THE TERRIBLE GAPING WOUNDS OF BOMBING, AND YET THERE THE WHOLE CITY STANDS, WITH HUMANITY SWIRLING AND POURING IN AND OUT, AND STILL UNDAUNTED HISTORY ON EVERY HAND. AS YOU DOUBTLESS KNOW, AFTER LEICESTER'S DEATH WE RECEIVED THE SECOND BLOW—OF LOSING MARY DEPREE, GEORGE'S SISTER. SHE DIED IN HER LITTLE HOUSE HERE IN RYE WHERE SHE HAD JUST MOVED LAST SUMMER AND WHERE SHE WAS ENJOY-ING LIFE TO THE FULL. WE CAME RIGHT OVER AND ARE NOW IN RESIDENCE IN CHEYNE HOUSE, AS IT IS CALLED. THE HOUSE IS LIKE ONE IN SO MANY OF THE ENGLISH TALES BY MRS. MOLESNORTH OR MRS. EWING THAT I USED TO LOVE AS A CHILD. IT FRONTS RIGHT ON THE HIGH STREET, BUT RYE IS ON A HIGH BLUFF OVERLOOKING THE ROTHER RIVER AND THE CAMBER SANDS. AT THE BACK OF MARY'S HOUSE THE LITTLE DRAWING ROOM HAS THIS WIDE VIEW RIGHT OUT TO THE CHANNEL ON A CLEAR DAY. THERE ARE THREE LITTLE STONE-FLAGGED TERRACES WITH BOX BUSHES AND POTS OF WALL FLOWERS JUST COMING INTO BLOOM IN SPITE OF THE 'BLIZZARD' (NOT RESEMBLING OURS) WHICH WE HAD STRAIGHT FROM MOSCOW JUST A WEEK AGO. IN LONDON, WHERE WE HAVE BEEN FOR FOUR DAYS, WE FOUND THE FOOD EXCELLENT AT BROWN'S WHERE WE WERE STAYING AND ALSO DELICIOUS AT THE RESTAURANTS WHERE WE MAPPENED TO BE. I THINK IN PART TO EARN AMERICAN DOLLARS, THEY ARE GIVING THE HOTELS EXTRA ALLOWANCES OF EVERYTHING. THERE IS A GREAT CHANGE FOR THE BETTER IN THIS RESPECT SINCE WE WERE HERE IN 149. THERE WAS ONE AMERICANISM WHICH TOOK PLACE WHILE WE WERE AT BROWN'S, AS THE LONDON PAPERS SAID AMERICAN MOMAN OF 73 ATTACKED IN BROWN'S HOTEL, THE NEXT LINE SAID MAN ESCAPES WITH 42,500 OF JEWELLERY. HE SAW HER IN THE LOBBY, WENT UP IN THE SAME 'LIFT', SAW WHAT HER ROOM NUMBER WAS, TAPPED ON HER DOOR, CAID HE HAD BEEN SENT UP TO FIX THE TELEPHONE. SHE LET HIM IN, WHEREUPON HE BOUND AND GAGGED HER, TIED HER UP WITH A SHEET AND DEPARTED WITH THE JEWELS. HE MUST HAVE BEEN TAKING LESSONS IN NEW YORK. SHE HAD TO GO TO THE HOSPITAL, BUT HE WAS LATER CAUGHT AT A TOWN OUTSIDE OF LONDON. FOR SO HIGHLY RESPECTABLE AND OLD FASHIONED PLACE THIS WAS QUITE STARTLING. WE ARE HAVING A QUIET PASSAGE HOME AND SHOULD BE BACK AT THE NUTS BY FRIDAY."

IT LOOKS LIKE A GOOD SET-UP, AND THE POST ITSELF REMINDS ME MORE OF A COLLEGE CAMPUS THAN AN ARMY BASE, WHICH I IMAGINE IS GOOD FOR THE MORALE. AND 18 THEIR SECOND SON AND FOURTH CHILD. HE IS A GRANDSON OF RICHARD COLLIER SARGENT, A GREAT-GRANDSON OF GEORGE LEWIS SARGENT, AND A GREAT-GREAT GRANDCHILD OF JOSEPH BRADFORD SARGENT (1822-1907). FRED WROTE THAT THE BOY'S "MIDDLE NAME IS HIS MATERNAL GRANDMOTHER'S MAIDEN NAME," AND FURTHER "HE LOOKS JUST LIKE OUR OTHER THREE DID AT HIS AGE-DARK, BLACK CURLY HAIR." THE FRED SARGENTS LIVE AT 410 YORKSHIRE PLACE, WEBSTER GROVES, MO.

JOHN NELSON DEMING, JR., SON OF JOHN N. (PAT) AND ANNA (CHUBBY) HUNTINGTON DEMING, WAS BORN ON THURSDAY, APRIL 24, AT 11:30 A.M. AT THE GRACE-NEW HAVEN COMMUNITY HOSPITAL, NEW HAVEN, CONN. HE WEIGHED 7 LBS, I3 OZ. AND IS THEIR SECOND CHILD, BOTH BOYS. HE IS A GRANDSON OF LAURA RICE DEMING, A GREAT-GRANDSON OF MAY SARGENT RICE, AND ACCORDING TO YE EDITOR'S COUNT, THE 52D GREAT-GRAND-CHILD OF JOSEPH BRADFORD SARGENT (1822-1907). CHUBBY ON APRIL 30 RETURNED HOME WITH THE BABY, WHO SHE SAYS LOOKS LIKE THE DEMINGS, AND THAT THE HOSPITAL USED WITH THE BABY THE "ROOMING-IN" METHOD INSTEAD OF IN THE NURSERY. RUPERT SARGENT HOLLAND

RUPERT SARGENT HOLLAND, SON OF MARY (MINNIE) BOGGS RUPERT HOLLAND, DIED ON MAY 3 IN THE BRYN MAWR (PA.) HOSPITAL. HE HAD NOT BEEN ILL LONG. HE WAS BORN OCTOBER 15, 1878, IN LOUISVILLE, KY. HE WAS 5 YEARS OLD WHEN THE FAMILY MOVED TO PHILADELPHIA, HIS FATHER, DR. JAMES WILLIAM HOLLAND, BECOMING PROFESSOR OF CHEMIS-TRY, LATER DEAN, AT JEFFERSON MEDICAL COLLEGE. RUPERT'S MOTHER WAS THE DAUGHTER OF ELON W. RUPERT AND LUCY BALDWIN SARGENT (1824-1895). THE LATTER WAS A SISTER OF JOSEPH BRADFORD SARGENT (1822-1907) AND GEORGE HENRY SARGENT (1828-1917), AND A DAUGHTER OF JOSEPH DENNY SARGENT (1787-1849) OF LEICESTER, MASS. RUPERT WAS MARRIED IN PROVIDENCE, R.I., TO MARGARET CURRIER LYON, DAUGHTER OF GEORGE C. LYON, WHO SURVIVES HIM. SHE HAS BEEN FOR SOME YEARS ON THE STAFF OF THE LIBRARY OF WAYNE. THEY HAVE HAD THREE CHILDREN: THE ELDEST, RICHARD LYON, A PRIVATE IN THE ARMY, WAS KILLED IN ACTION FEBRUARY 28, 1945, LEAVING A WIDOW, RITA HARDING HOLLAND AND A 5-YEAR OLD SON STEPHEN. RUPERT'S SECOND CHILD, ELEANOR SARGENT, WAS A WAC SERGEANT AND SERVED IN EUROPE. SHE IS THE WIFE OF LIEUTENANT WALTER J. ODRONIC BY WHOM SHE HAS A SON BREHON. RUPERT'S YOUNGEST, DAVID THURSTON, IS STUDYING AT HARVARD FOR A PH.D. DEGREE.

RUPERT PREPARED FOR COLLEGE AT WILLIAM PENN CHARTER SCHOOL, AND GRADUATED FROM HARVARD IN 1900. HE WAS AN EDITOR OF THE CRIMSON, LAMPOON, AND ADVOCATE. IN HIS HARVARD CLASS 25TH ANNIVERSARY BOOK HE WROTE: "AFTER GRADUATING FROM COLLEGE I ENTERED THE LAW SCHOOL OF THE UNIVERSITY OF PENNSYLVANIA, RECEIVED MY LL.B. DEGREE THERE IN 1903, AND WAS ADMITTED TO THE BAR. FOR A TIME I WAS THE ATTORNEY OF THE PHILADELPHIA LEGAL AID SOCIETY, THEN ENGAGED IN THE GENERAL PRACTICE OF LAW. LAW, HOWEVER, WAS NOT MY REAL INTEREST; I HAD ALWAYS WANTED TO WRITE, AND AS I GRADUALLY BEGAN TO FIND A MARKET FOR THE PRODUCTS OF MY PEN I DREW OUT OF LEGAL

PRACTICE AND INTO THE MUCH MORE ENGROSSING PURSUIT OF CONSTRUCTING SHORT STORIES AND NOVELS. I HAVE TRIED VARIOUS KINDS OF WRITING, SOME HISTORY, SOME BIOGRAPHY, BUT FIND MY LIKING CHIEFLY FOR FICTION. I HAVE WRITTEN A GOOD MANY BOOKS FOR BOYS, BOY SCOUT STORIES AND STORIES WITH HISTORICAL BACKGROUNDS. THE THEME OF MY NOVELS IS USUALLY MYSTERY OR ADVENTURE, OR A MIXTURE OF EACH." IN HIS 50TH ANNIVERSARY CLASS BOOK HE WROTE: ". . . LOOKING OVER MY SHELVES I FIND THAT I HAVE PUBLISHED FIFTY—FIVE BOOKS.
. . NOVELS, DETECTIVE STORIES, ADVENTURE STORIES FOR BOYS, BIOGRAPHIES, PLAYS AND A BOOK OF POEMS.
ONE OF THE ADVANTAGES OF BEING A WRITER IS THAT ONE DOESN'T HAVE TO RETIRE, AND I HOPE TO GO RIGHT ON WRITING." HE HAS ALSO SERVED AS LITERARY ADVISER TO SEVERAL PUBLISHING HOUSES.
