THE FOLLOWING IS ANOTHER EXTRACT FROM THE DIARY OF LIEUT. COL. JOSEPH SCRANTON TATE, JR., SON OF ALICE SARGENT TATE. IT IS DATED DECEMBER 13, 1942, AND DESCRIBES A RAID BY HIS BOMBER GROUP ON BIZERTA, A GERMAN BASE IN TUNISIA. HONIE, REFERRED TO, WAS IN A FLYING SCHOOL IN THE UNITED STATES.

"WELL TODAY HONIE GRADUATED FROM FLYING SCHOOL, AND I WENT ON MY FIRST RAID IN AFRICA. IT WAS A LONG ONE TOO. 600 MILES IF YOU PLANNED ON A ONE WAY TRIP AND 1220 IF YOU WANTED TO COME HOME. T-LAKE AND JERK IN TEGGIE ANN LED THE FIRST FLIGHT WITH PAT MURPHY, SIMS AND RINEHART IN TOW. STEW LED OUR FLIGHT WITH ME #2 AND JOHN MURPHY #3. THE 409TH WAS LAST AND THE 330TH SECOND. IT WAS A LONG RIDE FOR US AND TOOK US SEVEN HOURS TO ACCOMPLISH IT. THE FORMATION WAS NOT UP TO OUR USUAL STANDARD. WE TOOK OFF AN HOUR AHEAD OF TIME IN THE MIDST OF AN AIR RAID ALERT RIGHT BEHIND THE 178 OF THE 97TH AND 301ST. IT WAS A RAT RACE GETTING OUT WITH SO MANY DIFFERENT PLANES FLYING AROUND BUT WE FORMED AND LEFT OVER THE FIELD AT 9:00 AFTER STARTING UP AT 8:15. WE FORMED AT 2000' AND CLIMBED OUT HEADED DUE EAST TO 10,000%. WE LEVELED OUT AT 10,000 AND FLEW PAST MASCARA, ALGIERS, PHILIPPVILLE, BONE AND BEGAN OUR CLIMB TO 21,000%. THE FORMATIONS WERE SPREAD OUT ALL OVER THE SKY. WE SIGHTED OUR TARGET AT ABOUT 11:30 DOWN TO THE LEFT OF US THROUGH THE CLOUDS, AND WE HEADED IN. WE PASSED RIGHT OVER FEAVYVILLE (? TAFARAOU!?) JUST NORTH OF TUNIS AND IT WAS A TEMPTING TARGET. THERE WAS A WHOLE BAS IN OF SHIPS AND A WHOLE BATCH OF STORAGE TANKS. WE WENT ON IN TO THE DOCKS AT BIZERTA AND EICH REALLY DID A GOOD JOB. OF HIS FOUR BOMBS ONE HIT JUST SHORT OF THE DOCKS AND THE OTHER THREE WENT IN. EVERYONE MORE OR LESS PICKED THEIR OWN SPOTS. I SAW MURPHY J. DROP HIS AND MABEE'S STEEL HELMET CAME STREAMING OUT THE SIDE OF THE PLANE. HE HAD LOOKED OUT THE WAIST WINDOW AND THE WIND STRIPPED IT OFF. SLANKARD HIS TAIL GUNNER GAVE IT A FEW BURSTS AS IT WENT BY. WE TURNED RIGHT AND THE FLAK BEGAN. IT WAS VERY ACCURATE AND CAMF IN QUITE CLOSE AND IT WAS LUCKY OUR EVASIVE ACTION BEGAN AS PROMPTLY AS IT DID. WE WORMED OUT UNSCATHED EXCEPT FOR A FEW SCRATCHES AND NO ONE IN OUR FLIGHT WAS HURT. THE 330TH AND 1109TH WERE STRAGGLING AND GOT CAUGHT BY BOTH FLAK AND FIGHTERS. I SAW HOOVERS SHIP AFTER WE GOT BACK AND HE HAD HAD SEVERAL DIRECT FLAK HITS AND HIS SHIP WAS A MASS OF HOLES. Two OF - RATHER THREE OF HIS MEN WERE HIT. ONE IN THE EYE, ONE IN THE HEAD AND CHEST AND ANOTHER IN SEVERAL PLACES - LEG, CHEST, ARM. A BIG HUNK WENT IN ONE NOSE WINDOW, PASSED BETWEEN B AND N AND WENT ON OUT. SEVERAL OF THEIR SHIPS CAUGHT FLAK. THEY MADE A FIVE MINUTE BOMBING RUN AND THE AA ALL WERE TEED OFF ON THEM. THE 330TH WERE BANGED UP TOO. FIGHTERS CAUGHT THE STRAGGLERS. ROACH WENT DOWN WITH ONE ENGINE IN FLAMES - PUT IT OUT AND TRIED TO MAKE MONT BLANC. BEFORE HE REACHED THE FIELD HE HAD 3 ENGINES FEATHERED - ONE MAN JUMPED AND GOT DOWN OKAY. THE OTHER MOTOR POOPED OUT BEFORE HE COULD GET IN AND HE CRASHED FOUR MILES SHORT OF THE FIELD. A TRANS-PORT TAKING OFF REPORTED ON LANDING HERE THAT THEY HAD SEEN 4 MEN LEAVE THE SHIP ON THE GROUND. LITTLE SPARKS ON LOU BROWN'S SHIP WAS BADLY WOUNDED AS WERE A COUPLE OF OTHERS ON HIS SHIP AND LOU WENT IN AT ALGIERS WHERE SPARKY IS IN THE HOSPITAL. THEY WERE ATTACKED BY FIGHTERS WHICH IN THE DISTANCE LOOKED LIKE FW 190s PAINTED BROWN. KUNZE OF THE 330TH GOT BACK HERE OKAY BUT HIS PLANE WAS A MESS AND HE HAD SEVERAL WOUNDED. THE RIDE BACK WAS FAST AND WE PULLED ABOUT 2000 R.P.M. AND BETWEEN 30" AND 40" OF MERCURY MOST OF THE TIME. JUST AFTER WE LEFT THE TARGET THE #4 MANIFOLD PRESSURE GAUGE WAS SHOT --- BUT I BELIEVE IT WAS IN THE TRANSMITTER. THE HYDRAULIC PUMP CAUGHT FIRE AND SCARED HELL OUT OF US BUT SECOR FOUND THE FIRE AND PUT IT OUT. SAVING THE SHIP MORE OR LESS BECAUSE THE

PUMP IS RIGHT BELOW THE GAS LINES IN THE BOMB BAY. ONE BOMB BAY DOOR GOT JAMMED OPEN BECAUSE OF SPENT CARTRIDGES GETTING CAUGHT IN THE TRACKS AND # | GENERATOR WENT OUT. WE LANDED AT 3:15 AND WERE PICKED UP BY "MIKE" PHIPPS- (POLO PLAYER)-NOW AN INTELLIGENCE OFFICER AND WERE TAKEN TO THE BRIEFING ROOM AND INTERROGATED. THEN WE ATE AT 4:00 AND WENT BACK OUT TO THE SHIP, CHECKED HER OVER, REPAIRED THE PARTS NEEDED AND CLEANED THE GUNS, GOT STARTED LOADING BOMBS, GAS AND OXYGEN. CAME IN LATE TO-NIGHT WITH LITTLE OR NO TIME TO WRITE. WE TAKE OFF AGAIN IN THE MORNING, REVEILLE AT 5:30 (?), BREAKFAST 5:30, BRIEF AT 6, TAKEOFF AT EIGHT I GUESS. STEW AND MAJ. BAKER LEAD THE FIRST FLIGHT AND I LEAD THE SECOND. WE ARE THE FIRST ELEMENT. I DON'T KNOW THE REST OF THE FORMATION. IT IS LATE AND I MUST WRITE DAD A NOTE FOR HIS BIRTHDAY. I MUST GO NOW DARLING. THE SKY TONIGHT IS LOVELY, A LITTLE MOON AND NOT A CLOUD IN THE SKY, BEAUTIFUL BLUE TOO. A GOOD NIGHT FOR A RAID. I LOVE YOU DARLING. GOODNIGHT."

JOSEPH BRADFORD SARGENT (1822-1907), GRANDFATHER OF YE EDITOR'S GENERATION. WROTE THE FOL-LOWING FACETIOUS LETTER FROM NEW HAVEN OCTOBER 20, 1886, TO HIS WIFE, WHO WAS VISITING HER SISTER, MRS. SWAN. IN BOSTON.

"DEAR FLORENCE:

"INCLOSED IS THAT \$30.00 THAT YOU WANT TO USE TO BUY SOMETHING FOR YOURSELF WITH. CRAN-BERRIES ARE CHEAP IN BOSTON AND ONE BARREL WILL COST...\$6.00 POTATOES ARE ALSO BOUGHT THERE AT GOOD ADVANTAGE 50 BUSHELS AT 40¢ WILL COME TO 20.00

FREIGHT ON ALL \$30.00

YOU CAN TAKE COD FISH INSTEAD OF POTATOES OR CRANBERRIES, OR GET A BARREL OF NO. I MACKEREL. "Your experience in shopping and in housekeeping will guide your native good sense, and I HAVE NO DOUBT YOU WILL PURCHASE, WITH THE THIRTY DOLLARS, SOMETHING FOR YOURSELF THAT WILL BE JUDIclous.

"RUSSELL HAS GONE TO NEW LONDON TO SOMEBODYS WEDING. THE REMAINDER OF THE FAMILY ARE ALL WELL AND AT HOME.

THE SONS OF JOSEPH BRADFORD SARGENT (1822-1907) WHEN THEY WERE BOYS USED TO GET SOME INCOME BY SELLING CERTAIN KINDS OF SCRAP METAL TO THE SARGENT & COMPANY FACTORY. THE COMPANY'S CASH BOOK SHOWS THAT ON FEBRUARY 4, 1871, NED SARGENT WAS PAID \$8.65 FOR 133 LBS. OF LEAD. ON NOVEMBER 30, 1874, J.D. SARGENT WAS PAID 53 CENTS FOR OLD COPPER.
