

In 2002 he was called to be vice president for Church Relations and corporate secretary of the Board of Pensions for the Presbyterian Church (U.S.A.) Bill was actively involved as a volunteer ecumenical minister at the Trinity Episcopal Church in Asbury Park.

sembly News at the 218th General Assembly last summer, Bill wrote, "None of us knows how many days we will be granted. As you look into the mirror each and every day, take

time to marvel that you have been created in the image of God. Count vour blessings often...Share yourself abundantly with those who need encouragement, hope, and care...Keepthattwinkle in your eye and help the learn world laugh...May God continue to bless you and keep you as you claim the gift of life each day!"
